## EXPLANATORY NOTES

*This bill specifies that the Minister may, by regulation, determine certain conditions of employment of members of the staff of a college who are not members of a certified association within the meaning of the Labour Code, and not all such conditions. It empowers the Minister to require the colleges to adopt a management policy for such staff in order to regulate conditions of employment which are not determined by him.*

*The bill extends the period allowed to a college to forward its financial statements to the Minister from ninety days to four months.*

# Bill 28

## An Act to amend the General and Vocational Colleges Act

THE PARLIAMENT OF QUÉBEC ENACTS AS FOLLOWS:

**1.** Section 18.1 of the General and Vocational Colleges Act (R.S.Q., chapter C-29), enacted by section 27 of chapter 30 of the statutes of 1985, is amended

(1) by striking out the word “the” in the first line of the first paragraph;

(2) by inserting, after the first paragraph, the following paragraph:

“The regulations may require a college to adopt, within such time as the Minister may prescribe, a management policy for the staff described in the first paragraph in order to regulate conditions of employment which are not determined by the Minister. The regulations shall specify what matters the policy must cover and they may prescribe the modalities of consultation on the policy and of its adoption and implementation.”

**2.** Section 27 of the said Act is amended by replacing the words “ninety days” in the second line of the first paragraph by the words “four months”.

**3.** Regulations made by the Government and mentioned in Schedule I to this Act are deemed to have been adopted by the Minister of Higher Education and Science under section 18.1 of the General and Vocational Colleges Act as amended by this Act and they have effect from the date of their publication in the *Gazette officielle du Québec*.

4. This Act comes into force on (*insert here the date of assent to this Act*).
