



CHAPTER 8

An Act respecting the Saint-Sulpice Library

[Assented to, the 13th of March, 1941]

HIS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. The Minister of Public Works is authorized to sign a contract, with the Priests of Saint-Sulpice of Montreal, a corporation having its corporate seat in the city of Montreal, for the definitive acquisition of the Saint-Sulpice library in consideration of the payment, to be made out of the consolidated revenue fund, of all taxes (with interest) due to the city of Montreal by the said corporation and by the subsidiaries formed by it, namely, Montreal College Inc., and The Chomedy Land Company Limited, which taxes, with accrued interest to the 31st of March, 1939, amount to the sum of seven hundred and forty-two thousand and six dollars and fifty-nine cents.

Contract to acquire library authorized.

2. The library to be so acquired comprises the following immoveable properties, with the books and furniture of the said corporation therein contained:

What the library comprises.

"A lot of land and dependencies situated in the St. Louis ward of the said city of Montreal, known and designated on the official plan and book of reference of the said St. Louis ward as being lot number seven hundred and thirty-eight (No. 738), measuring one hundred and four feet in width by a depth of one hundred and sixty feet, with the buildings thereon erected;

"An emplacement situated in the St. Louis ward of the city of Montreal, being the southeasterly part of lot number seven hundred and forty-one (No. 741), on the

said official plan and book of reference of the St. Louis ward, the said emplacement measuring thirty-one feet seven inches in width in front by a depth of fifty-one feet two inches, and, from there, having another width of thirty-four feet by a further depth of one hundred and eight feet ten inches; bounded in front to the northeast by St. Denis street, in rear by a lane thirty feet in width, on the northwest side by the remainder of the said lot number seven hundred and forty-one, and on the southeast side by lot number seven hundred and thirty-eight; with a stone house whereof the northwesterly walls and gables are in common and the middle of the said gables forms the division line; and other buildings erected on the said land; with, in addition, the right of way in the said lane in the rear of the said lot in common with others having rights therein; subject to certain restrictions contained in the deed of acquisition."

Effect of the contract.

3. The execution of the contract hereinabove contemplated shall have the effect of withdrawing the properties therein dealt with from the operation of the provisions of the act 1 George VI, chapter 2, and of the cession contemplated in the said act.

Library made accessible to public.

4. The Provincial Secretary may take the requisite steps to render the said library accessible to the public, in accordance with such regulations as may be made by the Lieutenant-Governor in Council, who shall appoint the necessary officials and employees.

Expense.

The expense so incurred shall be paid out of the sums voted annually for such purpose by the Legislature.

Coming into force.

5. This act shall come into force on the day of its sanction.
