



CHAPTER 46

An Act to amend the Music Encouragement Act

[Assented to, the 13th of March, 1941]

HIS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. Notwithstanding the provisions of section 2 of the Music Encouragement Act (Revised Statutes, 1925, chapter 139), the Lieutenant-Governor in Council, so long as he considers that the international situation would not allow of going to Europe to study, may order that the winner of the competition provided for in the said section is authorized to carry on his musical studies in any foreign country.

2. This act shall take effect as from the 1st of August, 1940, and the Order-in-Council No. 2945 of the 2nd of August, 1940, reproduced as schedule A to this act, is ratified.

3. This act shall come into force on the day of its sanction.

SCHEDULE A

ORDER-IN-COUNCIL

EXECUTIVE COUNCIL CHAMBER

Concerning a grant of \$5,000.00 to the Academy of Music of Quebec.

Whereas the Music Encouragement Act (Revised Statutes of Quebec, 1925, chapter 139) was passed for the express purpose of encouraging music by stimulating competition between persons studying that art, and by procuring for the most deserving amongst them the means of receiving a superior education, as appears by the preamble of the act 1 George V (2nd. Session), chapter 5;

Whereas, by virtue of section 2 of the Music Encouragement Act, the competitor who obtains the highest number of marks in the special annual competition, opened by the Academy of Music of Quebec, has the right to spend two years in Europe, at the Academy's expense, to complete his musical studies;

Whereas the special competition of the Academy of Music of Quebec for the year 1940 was held and the Europe scholarship duly awarded to the person entitled thereto;

Whereas in view of present conditions in Europe the Academy of Music of Quebec points out that there is reason, for the duration of the war, to authorize the winner of the Europe scholarship to complete his musical studies, at the expense of the Academy of Music of Quebec, at one or more superior schools in the United States;

Therefore, upon the recommendation of the Honourable the Provincial Secretary, it is ordered that a sum of \$5,000.00 (five thousand dollars) be paid to the Academy of Music of Quebec, in conformity with the Music Encouragement Act (chapter 139 of the Revised Statutes of Quebec, 1925, section 2), the winner of the Europe scholarship being authorized, however, to carry on, upon the above-mentioned conditions, his musical studies in the United States; this order-in-council to be ratified by an act of the Legislature at its next session.
