



CHAPTER 50

An Act to amend the Courts of Justice Act

[Assented to, the 17th of May, 1941]

HIS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. Section 219 of the Courts of Justice Act (Revised Statutes, 1925, chapter 145) is replaced by the following: R. S., c. 145, s. 219, replaced.

"219. Each of the chief justices of the sessions shall receive an annual salary of eight thousand dollars, and each of the other judges of the sessions an annual salary of seven thousand dollars; such salaries shall be paid out of the consolidated revenue fund; and each such judge shall perform the duties of judge of the sessions as well as all other duties imposed upon him, or which may be imposed upon him, by any law in force in this Province." Salaries and duties of judges of sessions.

2. Section 221 of the said act is amended by replacing the words: "joint address of the Legislative Council and Legislative Assembly", in the second and third lines thereof, by the words: "report of the Court of King's Bench (Appeal Side) made after an inquiry upon the request of the Attorney-General". R. S., c. 145, s. 221, am.

3. Section 254 of the said act, as amended by the act 3 George VI, chapter 78, section 1, is replaced by the following: Id., s. 254, replaced.

"254. The Lieutenant-Governor in Council may appoint, during good behaviour, by commission under the Great Seal, judges of the Juvenile Delinquents' Court, not to exceed three in number." Appointment of judges of Juvenile Delinquents' Court.

4. Section 255 of the said act, as amended by the acts 22 George V, chapter 64, section 1, and 3 George VI, chapter 78, section 2, is replaced by the following:

Salaries of

"255. The judges of the Juvenile Delinquents' Court shall receive an annual salary of six thousand dollars, payable out of the consolidated revenue fund. The provisions of sections 236 to 241*b*, inclusive, shall apply to such judges and to their widows."

5. Section 272 of the said act, as amended by the act 18 George V, chapter 57, section 1, is replaced by the following:

Salaries of
District
Magistrates.

"272. The Chief District Magistrate shall receive an annual salary of seven thousand dollars, and each of the other magistrates shall receive an annual salary of six thousand dollars. Such salaries shall be paid out of the consolidated revenue fund."

6. Section 3 of the act 4 George VI, chapter 53, is replaced by the following:

"3. The judge of the said court shall receive an annual salary of six thousand dollars, payable out of the consolidated revenue fund.

Pension.

The provisions of sections 236 to 241*b*, inclusive, of the Courts of Justice Act shall apply to such judge and to his widow."

7. The provisions of this act shall apply to the judges and magistrates now in office, as well as to those to be hereafter appointed, and this, as from the date to be fixed by proclamation of the Lieutenant-Governor.
