



CHAPTER 77

An Act respecting the city of Grand'Mère and the school commissioners for the municipality of Grand'Mère in the county of Champlain and providing for a fixed valuation of the properties of certain companies

[Assented to, the 13th of March, 1941]

WHEREAS the city of Grand'Mère and the school commissioners for the municipality of Grand'Mère in the county of Champlain have, by their petition, represented: Preamble.

That the city of Grand'Mère, by its by-law bearing the number 375, has made provision, to be effective for a period of ten years: (a) for a fixed valuation of certain properties held by The Shawinigan Water and Power Company and by Consolidated Paper Corporation Limited; (b) for an annual contribution which must be paid to the said city by the said companies; (c) for the continuation of the functions of certain officers of the said city;

That the said by-law was approved by the elector-proprietors of the city of Grand'Mère;

That the valuations fixed by the said by-law have been accepted by the school commissioners for the municipality of Grand'Mère in the county of Champlain, by a resolution passed on the 2nd of December, 1940, to serve as the basis for the assessments to be imposed by the said commissioners during the said period;

That the valuations fixed by the said by-law are reasonable, fairly proportionate to those of the other ratepayers and sufficiently high to permit, in each case, of a proper administration;

Whereas the said city and the said commissioners have accordingly prayed for the passing of an act to confirm and ratify the said by-law and the said resolution; and

Whereas it is expedient to grant the prayer of the said city and the said commissioners;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

By-law

1. By-law number 375 of the city of Grand'Mère, providing, amongst other things, for a fixed valuation, during a period of ten years, of the taxable property of The Shawinigan Water and Power Company and of the taxable property of Consolidated Paper Corporation Limited, for an additional contribution from the said companies, and for the continuance in office of certain city officials, is confirmed, ratified and declared obligatory for the city of Grand'Mère, for the companies mentioned in the said by-law, for their successors and assigns and for all the ratepayers concerned.

2. The powers conferred upon Laurentide Company, Limited, by the act 21 George V, chapter 166, as regards the appointing and replacing of the manager of the city of Grand'Mère shall, from this day to the 31st of January, 1952, be exercised by Consolidated Paper Corporation Limited, the assign of the said Laurentide Company, Limited; and the powers conferred upon The Shawinigan Water and Power Company, respecting the same matter, by the same act, shall be continued from this day to the 31st of January, 1952.

Resolution
ratified.

3. The said resolution of the school commissioners for the municipality of Grand'Mère in the county of Champlain, passed on the 2nd of December, 1940, is confirmed, ratified and declared obligatory for the said school corporation, for the companies mentioned in the said resolution, for the successors and assigns of such companies and for the ratepayers concerned.

4. This act shall come into force on the day of its sanction.
