



CHAPTER 94

An Act respecting the name of Industrial Life Insurance Company

[Assented to, the 20th of March, 1941]

WHEREAS Industrial Life Insurance Company, a Preamble. legally constituted corporation having its head office in the city of Quebec, has, by its petition, represented:

That it was incorporated by the act 5 Edward VII, chapter 66;

That since its incorporation it has carried on the business of insurance, made contracts and generally exercised the powers specially conferred upon it by its charter and by the general laws applicable to insurance companies under the English names "Industrial Life Insurance Company" and "The Industrial Life Insurance Company" and the French names *L'Industrielle Compagnie d'Assurance-Vie* and *L'Industrielle Compagnie d'Assurance sur la Vie* and it has been known and proceedings have been taken against it under those names;

That there was no provision in its act of incorporation authorizing it to use the names *L'Industrielle Cie d'Assurance-Vie*, *L'Industrielle Compagnie d'Assurance sur la Vie* or the name "The Industrial Life Insurance Company";

That it now wishes to be expressly authorized to use the French name *L'Industrielle Compagnie d'Assurance sur la Vie* or the English name "Industrial Life Insurance Company" and to obtain a declaration that all insurance and other contracts as well as all documents signed for it under the names *L'Industrielle Cie d'Assurance-Vie* and *L'Industrielle Compagnie d'Assurance sur la Vie* as well as under the name

“The Industrial Life Insurance Company” have the same validity as if they had been made under the company’s authorized name;

That it is advisable and even necessary, in the interests of the company and its policyholders and of those generally towards whom it may be obligated or who may be obligated to it, that such an act should be passed;

Whereas it is expedient to grant the prayer contained in the said petition;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

- Name.** **1.** Industrial Life Insurance Company is authorized to carry on business under the said English name, “Industrial Life Insurance Company” or the French name *L’Industrielle Compagnie d’Assurance sur la Vie*.
- Validity of contracts, etc., made under certain names.** **2.** All insurance or other contracts and all documents signed for Industrial Life Insurance Company under the names *L’Industrielle Compagnie d’Assurance sur la Vie*, *L’Industrielle Cie d’Assurance-Vie* and “The Industrial Life Insurance Company” shall have the same validity as if they had been made under the name authorized by this act.
- Rights, etc., safeguarded.** **3.** The rights and obligations of the company shall not be affected by the provisions of this act and all proceedings which may have been taken by or against the company under any of the names mentioned in section 2 hereof may be continued under the same name.
- Coming into force.** **4.** This act shall come into force on the day of its sanction.
