# LETTERS PATENT

(RESPECTING THE TOWN OF SAINTE-ANNE-DE-BELLEVUE)

CANADA,  
Province of Quebec. }

*GEORGE VI, by the Grace of God, of Great Britain, Ireland and the British Dominions beyond the Seas, King, Defender of the Faith, Emperor of India.*

*To all to whom these presents shall come or whom the same may concern,*

GREETING.

**WHEREAS** subsection 3 of section 2 of the Cities and Towns' Act enacts that the Lieutenant-Governor in Council may grant Letters Patent to the effect of revoking the special charter of a city or town municipality and to subject the said town or the said city exclusively to the provisions of the Cities and Towns' Act;

Whereas the municipal council of the Town of Sainte-Anne-de-Bellevue, in the county of Jacques-Cartier, in conformity with a resolution duly adopted at its meeting of the 1st of September, 1938, has presented to Us a petition requesting to abandon the special acts 58 Vict., c. 56; 63 Vict., c. 57, and 6 Edward VII, c. 54, which govern it and which constitute its charter, and be subjected exclusively to the provisions of the Cities and Towns' Act;

Whereas all the formalities prescribed by the said Act have been fulfilled;

Therefore, with the advice and consent of Our Executive Council, expressed in an order dated the 7th of December, 1938, We grant the request of the municipal council of the Town of Sainte-Anne-de-Bellevue, dated the 6th of September, 1938, and we do declare and order by these present Letters Patent which shall come into force on and from the date of their publication in the *Quebec Official Gazette* that the said Town be sub-

jected exclusively to the provisions of the Cities and Towns' Act, the said Town continuing to be designated under its corporate name, namely "The Town of Sainte-Anne-de-Bellevue" and to be divided into three wards, that is to say, the East, Center and West Wards, as they subsist actually, each ward being represented in the council by two aldermen and the mayor being elected by the electors of the whole Town, the said Town conserving its present limits as described in the statutes incorporating it, the whole in conformity with the provisions of subsection 3 of section 2 of chapter 102 of the Revised Statutes, 1925.

OF ALL WHICH OUR loving subjects, and all others whom these presents may concern, are hereby required to take notice and to govern themselves accordingly.

IN TESTIMONY THEREOF, We have caused these Our Letters to be made Patent and the Great Seal of the Province of Quebec to be hereunto affixed. WITNESS: Our Right Trusty and Well Beloved the Honourable ÉSIOFF-LÉON PATE-NAUDE, Member of Our Privy Council for Canada, Lieutenant-Governor of Our Province of Quebec.

At Our Government House, in Our City of QUEBEC, in Our said Province, this TWENTY-FIRST day of DECEMBER, in the year of Our Lord one thousand nine hundred and thirty-eight and in the third year of Our Reign.

Whereas it is expedient to enact that the said Act will apply to the organizations hereinafter mentioned;

IT IS THEREFORE enacted that, upon recommendation of the Honourable the Prime Minister, the Act to establish a general purchasing service for the Government (3 George VI, chapter 14) shall apply to

The Quebec Municipal Commission;

The Quebec Old Age Pensions Commission;

The Quebec Farm Credit Bureau.

RESPECTING THE ESTABLISHMENT, IN THE DEPARTMENT OF THE EXECUTIVE COUNCIL, OF A CINE-PHOTOGRAPHIC SERVICE

IT IS ORDERED, upon recommendation of the Honourable the Prime Minister, that there be established, in the Department of the Executive Council, a service called: "Cinephotographic Service", to which the General Purchasing Director will be bound to entrust the management of everything which may concern cinematography for all the departments and all the organizations under his control.

IT IS ORDERED, moreover, that all the departments and organizations hereinabove mentioned be bound to place with the Cinephotographic Service any cinema apparatus and accessories in their possession, and that no new apparatus of that kind be purchased for them in future.

OUT OF THE YOUTH AID ACT TO THE  
DEPARTMENT OF THE PROVINCIAL  
SECRETARY

IT IS ORDERED, upon recommendation of the Honourable the Minister of Municipal Affairs, Trade and Commerce, that, from and after the 6th of March, 1941, the Provincial Secretary, instead of the Minister of Municipal Affairs, Trade and Commerce, be charged with the carrying out of the Youth Aid Act (2 George VI, chapter 5, as amended by the act 3 George VI, chapter 5) and the signing and fulfilling of the agreements contemplated by the said act. Nevertheless, the Minister of Municipal Affairs, Trade and Commerce shall continue to be charged with whatever relates to the obtaining of employment for young persons.
