



## CHAPTER 111

An Act respecting the parishes of St. Clothilde, St. Ephrem-de-Tring and St. Méthode-d'Adstock

*[Assented to, the 14th of June, 1940]*

**W**HEREAS the parish of St. Clothilde, in the county <sup>Preamble.</sup> of Beauce, was erected as a municipality by a proclamation on November 7th, 1938, replaced by the act 3 George VI, chapter 129; and

Whereas the description of the territory of the said municipality in the said proclamation and in the said act contains inexactitudes which should be corrected;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

**1.** The following territory, detached from the here-<sup>Municipality</sup>inafter enumerated municipalities, is erected into a <sup>of the parish</sup>municipality under the name of "municipality of the <sup>of St. Clo-</sup>parish of St. Clothilde", and, for municipal purposes, <sup>thilde, erect-</sup>it shall form part of the county of Beauce, the part described in sub-paragraph *a* being detached from the county of Megantic:

*a.* A part of the municipality of the south part of the parish of Sacré-Cœur-de-Marie, in the county of Megantic, comprising, in the eleventh range of the township of Broughton, according to the official cadastre of the said township, the lot No. 25c, the parts of the lots Nos. 25a, 25b, 25d, 26a and 26b situated to the northeast of the *grande ligne* road, and the lots Nos. 27a, 27b, 27c, 27d, 28a and 28b;

b. A part of the municipality of the parish of Sacré-Cœur-de-Jésus, in the county of Beauce, comprising, firstly, in the township of Tring, according to the official cadastre of the parish of St. Victor, the lots Nos. 709, 710, 711 and 712, in the sixth range and, according to the official cadastre of the parish of St. Ephrem, the parts of the seventh and eighth ranges situated respectively to the northwest of the south-eastern lateral lines of lots Nos. 155 and 161; secondly, in the township of Broughton, according to the official cadastre of the said township, the south-west parts of lots Nos. 24a and 24b of the eighth range on a depth of about eight arpents, the part of the eighth range situated to the southeast of the northwestern lateral line of lot No. 26a, the parts of the ninth and tenth ranges situated respectively to the southeast of the northwestern lateral lines of lots Nos. 23c of the ninth range and 25a and 25e of the tenth range;

c. A part of the municipality of St. Victor-de-Tring, in the county of Beauce, comprising, in the sixth range of the township of Tring, the northwest half of the lot No. 708 of the official cadastre of the parish of St. Victor;

d. A part of the municipality of St. Ephrem-de-Tring, in the county of Beauce, comprising, in the township of Tring, according to the official cadastre of the parish of St. Ephrem, the lots of the seventh range comprised between the northwestern lateral line of lot No. 154 and the southeastern lateral line of lot No. 128, the lots of the eighth range comprised between the northwestern lateral line of lot No. 162 and the southeastern lateral line of lot No. 190, the parts of the ninth, tenth and eleventh ranges situated respectively to the northwest of the southeastern lateral lines of lots Nos. 357, 423 and 538.

2. The lot No. 537 of the official cadastre of the parish of St. Ephrem, in the eleventh range of the township of Tring, is, for all purposes, detached from the municipality of St. Ephrem-de-Tring and from the county of Beauce, and annexed to the municipality of the parish of St. Méthode-d'Adstock and to the county of Frontenac.
