



CHAPTER 112

An Act to erect the municipality of Mont Tremblant, in the County of Terrebonne

[Assented to, the 17th of May, 1940]

WHEREAS Reverend Charles Hector Deslauriers, Préamb.
vicar of the parish of Sacred Heart of Jesus, a
religious parish situated in the counties of Terrebonne
and Labelle, has, by his petition, represented:

That the majority of the proprietors within the boundaries of the said parish of Sacred Heart of Jesus, as established in 1929, have consented in writing to the erection of a rural municipality having the same territorial area as the said religious parish under the name "Municipality of Mont Tremblant", in the county of Terrebonne;

That within the said territorial area is a population of about six hundred souls;

That the said territorial area, which for many years has been the recreation ground of summer residents, visitors and sportsmen, has more recently become an important centre for winter sports and tourism, thus requiring urgent improvements as regards roads, drainage, lighting and embellishment which the existing municipalities have not been willing to make;

That the proprietors concerned are desirous of encouraging and developing tourism and those industries associated therewith, all of which require improved municipal conditions;

That no provision is made in the Municipal Code for the erection of a rural municipality having parts of its territory in two counties and it is therefore necessary

for the petitioner to apply to the Legislature for a special act;

Whereas it is expedient to grant the prayer contained in the said petition;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

Territory.

1. The following territories are detached from the municipality of the united townships of Salaberry and Grandison, in the county of Terrebonne, and from the municipality of the township of Clyde, in the county of Labelle, and are erected into a separate rural municipality under the name of "Municipality of Mont Tremblant", and shall form part of the county of Terrebonne for all municipal purposes:

a. Lots 560 to 580 inclusive, and the parts of lots 581, 582 and 583, bounded to the south and to the southeast by a line parallel to the road which turns around Lac Ouimet at a distance of three hundred feet to the south and to the southeast of the said road, in range VIII of the township of Salaberry, in the county of Terrebonne;

b. Lots 14 to 37 inclusive of ranges I, II and III; lots 14 to 26 inclusive of range IV; lots 27 to 32 inclusive of range V, and lots 33 to 36 inclusive of range VI of the township of Grandison, in the said county of Terrebonne;

c. Lots 1 to 8 inclusive of range "B" and lots 1 to 10 inclusive of ranges "C", "D" and "E" of the township of Clyde, in the municipality of the said township, in the county of Labelle.

2. The provisions of the Municipal Code shall apply to the apportionment of assets and liabilities as between the municipalities herein concerned.

3. The provisions of section 1 of this act shall not have the effect of altering or modifying, for purposes other than municipal purposes, any provisions of law governing the territory described therein.

4. The municipality of Mont Tremblant shall be bound to pay to the municipality of the united townships of Salaberry and Grandison on the 1st of September of each year, during twenty consecutive years,

the sum of one hundred dollars (\$100.00) and the first of such annual payments shall become due on the 1st of September, 1940.
