LETTERS PATENT

WHEREAS subsection 2 of section 2 of the Cities and Towns' Act, chapter 102, R. S. Q., 1925, enacts that the Lieutenant-Governor in Council, on petition from the council of a municipality, may issue letters patent amending the charter of such corporation, by replacing certain provisions thereof by the corresponding ones of this act;

Whereas the council of the town of Megantic, by its petition bearing date the 27th of September, 1939, requests that letters patent be issued in its behalf to amend its charter (Act 7 Edward VII, chap. 77), by replacing section 9 thereof by the corresponding provision of the Cities and Towns' Act, that is to say by section 48 of chapter 102 of the Revised Statutes of Quebec, 1925;

Whereas all the formalities prescribed by the law have been fulfilled;

Whereas it is expedient to grant this petition;

Therefore, with the advice and consent of Our Executive Council, expressed in an order dated the 13th of January, 1940, We grant the petition of the municipal council of the town of Megantic, bearing date the 27th of September, 1939, and We declare and order by these present letters patent, which will come into force on and from the date of their publication in the

Quebec Official Gazette, that the charter of the said town be amended by replacing section 9 thereof by section 48 of the Cities and Towns' Act, the whole in conformity with the provisions of subsection 2 of section 2 of the Cities and Towns' Act, chapter 102, R. S. Q., 1925.

OF ALL WHICH OUR living subjects, and all others whom these presents may concern, are hereby required to take notice and to govern themselves accordingly.

IN TESTIMONY WHEREOF, We have caused these Our Letters to be made Patent and the Great Seal of the Province of Quebec to be hereunto affixed. Concerning the tariff of registrars and the application of the provisions of the Act 4 George VI, chapter 69, respecting the pledge of agricultural property
