



## CHAPTER 38

### An Act to amend the Agricultural Society Act

[Assented to, the 28th of April, 1939]

**HIS MAJESTY**, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

**1.** Section 10 of the Agricultural Society Act (Revised Statutes, 1925, chapter 54) is amended by replacing the word: "Council", in the fourth line thereof, by the word: "Minister". R.S., c. 54, s. 10, am.

**2.** Section 11 of the said act is amended:

*a.* By replacing the word: "Council", in the third line thereof, by the word: "Minister".

*b.* By replacing the word: "Council", in the tenth line thereof, by the word: "Minister".

**3.** Section 15 of the said act is amended:

Id., s. 15, am.

*a.* By replacing the word: "Council", in the second line of the second paragraph thereof, by the word: "Minister".

*b.* By replacing the word: "Council", in the third line of the said second paragraph thereof, by the word: "Minister".

**4.** Section 17 of the said act is amended by replacing the word: "Council", in the fourth line thereof, by the word: "Minister". Id., s. 17, am.

**5.** Section 19 of the said act is amended by replacing the words: "Council of Agriculture", in the ninth line thereof, by the words: "Quebec Chamber of Agriculture". Id., s. 19, am.

**6.** Section 37 of the said act is amended:

- a. By replacing the word: "Council", in the last line of the first paragraph thereof, by the word: "Minister";
- b. By replacing the word: "Council", in the first line of the second paragraph thereof, by the word: "Minister".

**7.** Section 39 of the said act is amended by replacing the word: "Council", in the third line thereof, by the word: "Minister".

Id., s. 40, am.

**8.** Section 40 of the said act is amended by replacing the word: "Council", in the first line thereof, by the word: "Minister".

**9.** Section 42 of the said act is amended by replacing the words: "Council of Agriculture", in the last line of the first paragraph thereof, by the words: "Quebec Chamber of Agriculture".

**10.** Section 43 of the said act, as amended by the acts 19 George V, chapter 23, section 1, and 22 George V, chapter 36, section 1, is replaced by the following:

Holding of

**43.** A general meeting of the members of every county agricultural society shall be held on the fourth Tuesday of January, and, in any county where there is no society, a meeting for the formation of a society may be held on the same date or on a day fixed by the Minister of Agriculture."

**11.** Section 45 of the said act is amended:

- a. By replacing the word: "Council", in the first line of the second paragraph of subsection 1 thereof, by the word: "Minister";
- b. By striking out the words: ", upon producing a copy of the resolution of the council establishing his appointment, ", in the second, third and fourth lines of the said second paragraph of the said subsection 1 thereof.

**12.** Section 46 of the said act is amended by replacing the word: "Council", in the first line of the third paragraph thereof, by the word: "Minister".

**13.** Section 49 of the said act is amended by replacing the words: "Council of Agriculture", in the last line thereof, by the words: "Quebec Chamber of Agriculture".

**14.** Section 54 of the said act, as amended by the act R.S., c. 54, s. 21 George V, chapter 39, section 1, is again amended by replacing the words: "to be exercised by the Council of Agriculture and", in the first and second lines thereof, by the word: "of". 54, am.

**15.** Section 55 of the said act is amended by replacing the words: "Council of Agriculture", in the last line of the first paragraph thereof, by the words: "Quebec Chamber of Agriculture". Id., s. 55, am

**16.** Section 57 of the said act is amended: Id., s. 57, am.

*a.* By replacing the words: "Council of Agriculture", in the third line thereof, by the words: "Quebec Chamber of Agriculture";

*b.* By replacing the word: "Council", in the seventh line thereof, by the word: "Chamber".

**17.** Section 64 of the said act is amended by replacing the word: "Council", in the fifth line of the second paragraph thereof, by the word: "Department". Id., s. 64, am

**18.** Section 67 of the said act is amended: Id., s. 67, am.

*a.* By replacing the words: "Council of Agriculture", in the fourth line of the second paragraph thereof, by the words: "Quebec Chamber of Agriculture";

*b.* By replacing the words: "Council of Agriculture", in the fourth line of the third paragraph thereof, by the words: "Quebec Chamber of Agriculture";

*c.* By striking out the last paragraph thereof.

**19.** The said act is amended by adding thereto, after section 70 thereof, the following: Id., s. 70a, added.

"**70a.** Agricultural societies may, during their exhibitions, sell by auction the farm stock exhibited by them or cause them to be sold by any unlicensed person, without being bound to pay duty." Sale exempt from duty.

**20.** Section 21 of the Council of Agriculture Act (Revised Statutes, 1925, chapter 52) is repealed. R.S., c. 52, s. 21, repealed.

**21.** Section 10 of this act shall be in effect as from the 1st of January, 1939. Retroactivity.

Recommendation prior to exercise of powers.

**22.** All the powers conferred upon the Minister of Agriculture under this act shall be subject to the recommendation of the Quebec Chamber of Agriculture.

Coming into force.

**23.** This act shall come into force on the day of its sanction.
