



## CHAPTER 86

### An Act to amend the Quebec Companies' Act

*[Assented to, the 30th of March, 1939]*

**HIS MAJESTY**, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

**1.** Section 4 of the Quebec Companies' Act (Revised R.S., c. 223, Statutes, 1925, chapter 223) is amended by replacing the words: "Provincial Secretary", in the ninth line of subsection 2 thereof, by the words: "Attorney-General or the Deputy Attorney-General". s. 4, am.

**2.** Section 7 of the said act is amended by replacing the words: "Provincial Secretary", in the second and third lines of the first paragraph thereof, by the word: "Attorney-General". Id., s. 7, am.

**3.** Section 8 of the said act is amended: Id., s. 8, am.

*a.* By replacing the words: "Provincial Secretary", in the second line of the third paragraph thereof, by the word: "Attorney-General";

a. By inserting therein, after the word: "Attorney-General", in the third line of subsection 1 thereof, the words: "or the Deputy Attorney-General";

b. By inserting therein, after the word: "Attorney-General", in the first line of subsection 2 thereof, the words: "or the Deputy Attorney-General";

c. By replacing the words: "Provincial Secretary", in the sixth line of the said subsection 2 thereof, by the words: "Attorney-General or the Deputy Attorney-General".

**14.** The said act is amended by adding thereto, after Id., ss. 28a, 28b, added. section 28 thereof, the following sections:

"**28a.** The company cannot in the carrying out of its Use of name. affairs use any name other than that given to it by the letters patent.

"**28b.** Every company infringing the provisions of Penalty for infringement. section 28a shall be liable, in addition to the costs, to a fine of not less than fifty dollars nor more than one hundred dollars for each day of such infringement."

section 122 thereof, the following sections:

"**122a.** The company cannot in the carrying out of its Use of name.  
affairs use any name other than that given to it by the letters patent.

"**122b.** Every company infringing the provisions of Penalty for infringement.  
section 122a shall be liable, in addition to the costs, to a fine of not less than fifty dollars nor more than one hundred dollars for each day of such infringement."

**45.** The orders-in-council adopted prior to the coming into force of this act under the authority of sections 22, 116 and 208 of the Quebec Companies' Act (Revised Statutes, 1925, chapter 223) shall remain in force notwithstanding the amending of these sections by this act and they shall apply, *mutatis mutandis*, to any act which must be performed by the Attorney-General, the Department over which he presides or any officer of such Department.

**46.** This act shall come into force on the day of its sanction.
