



## CHAPTER 129

An Act to erect the parish of St. Clothilde,  
in the electoral district of Beauce

[Assented to, the 28th of April, 1939]

**HIS MAJESTY**, with the advice and consent of the  
Legislative Council and of the Legislative Assembly  
of Quebec, enacts as follows:

**1.** The following territories are detached from the municipality of the southern part of the parish of Sacré-Cœur-de-Marie, in the electoral district of Megantic, and from the municipalities of Sacré-Cœur-de-Jésus, St. Victor-de-Tring and St. Ephrem-de-Tring, in the electoral district of Beauce, and are erected into a separate municipality under the name of "municipality of the parish of St. Clothilde", in the county of Beauce:

*a.* a part of the municipality of the southern part of the parish of Sacré-Cœur-de-Marie, in the electoral district of Megantic, comprising, in the eleventh range of the township of Broughton, reference being to the official cadastre made for the said township, lot No. 25*c*, the parts of lots Nos. 25*b*, 25*d*, 26*a* and 26*b*, situated northeast of the *Grande Ligne* road, lots Nos. 27*a*, 27*b*, 27*c*, 28*a* and 28*b*;

*b.* a part of the parish municipality of Sacré-Cœur-de-Jésus, in the county of Beauce, comprising: in the township of Tring, reference being to the official cadastre made for the parish of St. Victor, lots 709, 710, 711 and 712 of the sixth range, and, reference being to the official cadastre made for the parish of St. Ephrem, the parts of the seventh and eighth ranges situated respectively northwest of the southeast side lines of los Nos. 155 and 161; in the township of Broughton, reference being to the official cadastre

made for the said township, the southwest parts of lots Nos. 24a and 24b of the eighth range through a depth of around eight arpents; the part of the said eighth range situated southeast of the northwest side line of lot No. 26a; the parts of the ninth and tenth ranges situated respectively southeast of the northwest side lines of lots Nos. 23c, 24a and 24e;

c. a part of the municipality of St. Victor-de-Tring, in the county of Beauce, comprising, in the sixth range of the township of Tring, the northwest half of lot No. 708 of the official cadastre made for the parish of St. Victor;

d. a part of the municipality of St. Ephrem-de-Tring, in the county of Beauce, comprising in the township of Tring, reference being to the official cadastre made for the parish of St. Ephrem, the lots of the seventh range comprised between the northwest side line of lot No. 154 and the southeast side line of lot No. 128; the lots of the eighth range comprised between the northwest side line of lot No. 162 and the southeast side line of lot No. 191; the parts of the ninth, tenth and eleventh ranges situated respectively northwest of the southeast side lines of lots Nos. 356, 423 and 537, with the exception, however, of the two and one-half southern arpents of such lot 537 of the parish of St. Ephrem, which two and one-half arpents are detached from the parish of St. Ephrem and annexed, for all purposes, to the parish of St. Méthode d'Adstock.
