



## CHAPTER 18

An Act to amend the Act to promote the reopening of the mills in the Chicoutimi region

*[Assented to, the 18th of March, 1938]*

**HIS MAJESTY**, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

**1.** Section 1 of the act 1 George VI, chapter 6, is <sup>1 Geo. VI,</sup> amended: <sub>c. 6, s. 1, am.</sub>

*a.* By replacing the words: "mill reopening or mill construction", in the third line of sub-paragraph *a* thereof, by the words: the reopening or the construction of mills";

*b.* By adding thereto, after the word: "Chicoutimi", in the fourth line of the said sub-paragraph *a*, the words: "or within a radius of one mile from the said city".

**2.** The said act is amended by adding thereto, after <sup>Id., s. 1a,</sup> section 1 thereof, the following section: <sub>added.</sub>

"**1a.** The Lieutenant-Governor in Council may authorize the Minister of Lands and Forests to acquire, by mutual agreement or by expropriation, any mill and immoveable property or immoveable right in the city of Chicoutimi or within a radius of one mile from the said city, the acquisition whereof the Lieutenant-Governor in Council may deem necessary for the purposes above set forth. <sup>Acquiring of certain mills, etc., authorized.</sup>

He may also, for the same purposes, authorize the said <sup>Id., of certain bonds, etc.</sup> Minister to purchase, in whole or in part, the capital-stock, the bonds and any other securities of any company operating or wishing to operate a mill in the city of Chicoutimi or within a radius of one mile from the said city."

**3.** Section 2 of the said act is replaced by the following:

**"2.** Any expropriation contemplated under this act shall be proceeded with, *mutatis mutandis*, in conformity with the act 1 George VI, chapter 38."

**4.** Section 4 of the said act is replaced by the following:

**"4.** A copy of each order and of each regulation enacted by the Lieutenant-Governor in Council in virtue of the provisions of this act shall be laid before the Legislative Assembly during the ensuing Session."

**5.** Section 5 of the said act is amended by replacing the words: "fifteenth day from the opening of the ensuing Session", in the third and fourth lines thereof, by the words: "first of May, 1939".

**6.** In fixing the compensation for expropriation carried out under section 2 of the act 1 George VI, chapter 6, no account shall be taken of the speculative value or increased value which the property may have acquired through the passing or carrying out of the said act 1 George VI, chapter 6, and its amendments.

**7.** This act shall come into force on the day of its sanc-  
tion.
