



## CHAPTER 74

An Act to amend the Act 58 Victoria, chapter 45, respecting the tenure of lands in the Magdalen Islands

[Assented to, the 8th of April, 1938]

**HIS MAJESTY**, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

**1.** Section 10 of the act 58 Victoria, chapter 45, is <sup>58 Vict., c. 45, s. 10, am.</sup> amended by replacing the words: "the office of the clerk of the Circuit Court of the Magdalen Islands, at the court house in Amherst Island", in the second, third, and fourth lines thereof, by the words: "such place, in the Magdalen Islands, as may be fixed by the Lieutenant-Governor in Council under section 10a".

**2.** The said act is amended by adding thereto, after <sup>Id., s. 10a, added.</sup> section 10 thereof, the following:

"**10a.** The Lieutenant-Governor in Council may <sup>Appointing of trustee.</sup> appoint a trustee to receive the amounts paid for the redemption of the rents in virtue of this act and fix his salary, payable out of the consolidated revenue fund.

The Lieutenant-Governor in Council shall fix the place, <sup>Place of redemption.</sup> in the Magdalen Islands, at which such redemption may be effected."

**3.** Section 11 of the said act, as replaced by the act 60 <sup>58 Vict., c. 45, s. 11, am.</sup> Victoria, chapter 14, section 2, is amended:

*a.* By replacing the words: "The clerk of the said court is, *ex-officio*, under this act, trustee", in the first and second lines thereof, by the words: "The trustee appointed under section 10a is charged";

b. By replacing the word: "*pour*", in the sixth line of the French version thereof, by the word: "*de*".

4. Section 12 of the said act, as amended by the act 59 Victoria, chapter 38, section 2, and as replaced by the act 60 Victoria, chapter 14, section 3, is amended by replacing the words: "clerk of the Circuit Court of the Magdalen Islands, in Amherst Island", in the fifth, sixth and seventh lines thereof, by the word: "trustee".

5. Section 13 of the said act, as amended by the act 59 Victoria, chapter 38, section 2, and as replaced by the act 60 Victoria, chapter 14, section 3, is amended by replacing the words: "Circuit Court of the said Islands", in the fourth line thereof, by the word: "trustee".

6. Section 13a of the said act, as enacted by the act 60 Victoria, chapter 14, section 3, is amended:

a. By replacing the word: "clerk", in the first line thereof, by the word: "trustee";

b. By replacing the word: "clerk", in the fourth line thereof, by the word: "trustee".

7. Section 13b of the said act, as enacted by the act 5 George V, chapter 28, section 3, is amended:

a. By replacing the word: "clerk", in the fourth line of the first paragraph thereof, by the word: "trustee";

b. By replacing the word: "clerk", in the second line of the second paragraph thereof, by the word: "trustee";

c. By replacing the word: "clerk", in the second line of the third paragraph thereof, by the word: "trustee";

d. By replacing the word: "clerk", in the seventh line of the said third paragraph thereof, by the word: "trustee".

8. Section 14 of the said act, as replaced by the act 5 George V, chapter 28, section 4, is amended:

a. By replacing the word: "clerk", in the third line thereof, by the word: "trustee";

b. By replacing the word: "clerk", in the sixth line thereof, by the word: "trustee".

9. Section 15 of the said act, as amended by the acts 60 Victoria, chapter 14, section 4, and 5 George V, chapter 28, section 5, is again amended:

a. By replacing the words: "clerk, in his quality of trustee," in the fourth line of the first paragraph thereof, by the word: "trustee";

b. By replacing the word: "clerk's", in the third line of the second paragraph thereof, by the word: "trustee's";

c. By replacing the words: "clerk, in his quality of trustee," in the fourth line of the said second paragraph thereof, by the word: "trustee";

d. By replacing the word: "clerk", in the second line of the third paragraph thereof, by the word: "trustee".

**10.** Section 20 of the said act, as amended by the act <sup>58 Vict., c. 60</sup> Victoria, chapter 14, section 6, is again amended by <sup>45, s. 20, am.</sup> replacing the words: "and to the clerk of the Circuit Court of the Magdalen Islands in Amherst Island", added to the said section 20 by the said act 60 Victoria, chapter 14, section 6, by the words: "and to the trustee appointed in virtue of this act".

**11.** This act shall come into force on such date as it may please the Lieutenant-Governor in Council to fix <sup>Coming into force.</sup> by proclamation.
