



## CHAPTER 101

An Act to amend Articles 639, 717, 1029, 1048, 1069 and 1352 of the Code of Civil Procedure

*[Assented to, the 12th of April, 1938]*

**HIS MAJESTY**, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

**1.** Article 639 of the Code of Civil Procedure, as amended by the acts 6 Edward VII, chapter 42, section 2; 1 George V (1st Session), chapter 44, section 1; 2 George V, chapter 49, sections 2 and 3, and 9 George V, chapter 79, section 1, is again amended by replacing the words: "and St. John's", in the eighth line of the first paragraph thereof, by the words: "<sup>C. C. P., art. 639, am.</sup>, St. John's and Joliette".

**2.** Article 717 of the said Code, as amended by the acts 6 Edward VII, chapter 42, section 3; 1 George V (1st Session), chapter 44, section 2, and 9 George V, chapter 79, section 2, is again amended by replacing the words: "or St. John's", in the third, and in the tenth and eleventh lines of paragraph 1 thereof, by the words: "<sup>Id., art. 717, am.</sup>, St. John's or Joliette".

**3.** Article 1029 of the said Code, as amended by the acts 6 Edward VII, chapter 42, section 4; 1 George V (1st Session), chapter 44, section 3, and 9 George V, chapter 79, section 3, is again amended by replacing the words: "and St. John's", in the third line of the second paragraph thereof, by the words: "<sup>Id., art. 1029, am.</sup>, St. John's and Joliette".

**4.** Article 1048 of the said Code, as amended by the acts 6 Edward VII, chapter 42, section 6; 1 George V (1st Session), chapter 44, section 4, and 9 George V, chapter 79, section 4, is again amended by replacing the words: "or St. John's", in the seventh line of paragraph 2 thereof, by the words: ", St. John's or Joliette".

**5.** Article 1069 of the said Code, as amended by the acts 6 Edward VII, chapter 42, section 7; 1 George V (1st Session), chapter 44, section 5, and 9 George V, chapter 79, section 5, is again amended by replacing the words: "or St. John's", in the seventh line of paragraph 2 thereof, by the words: ", St. John's or Joliette".

**6.** Article 1352 of the said Code, as amended by the acts 6 Edward VII, chapter 42, section 8; 1 George V (1st Session), chapter 44, section 6, and 9 George V, chapter 79, section 6, is again amended by replacing the words: "or St. John's", in the eighth line of paragraph 1 thereof, by the words: ", St. John's or Joliette".
