



CHAPTER 142

An Act to validate the clerkship of Jacques Feeney

[Assented to, the 8th of April, 1938]

WHEREAS Jacques Feeney, notarial student, of the Preamble.
town of Laprairie, has, by his petition, represented:

That he was regularly admitted to the study of the notarial profession on the 10th of July, 1928;

That, on the 14th of July, 1928, he entered into articles of clerkship with Mtre Jos. Sirois, notary, at Quebec, by deed before Mtre B. Feeney, which articles were duly registered in the secretary's office of the Board of Notaries on the 23rd of July following, under No. 763;

That, on the 13th of November, 1928, these articles were transferred by Mtre. Joseph Sirois to Mtre. John Fair, notary, at Montreal, by deed before Mtre. B. Feeney, and such transfer of articles was duly registered in the secretary's office of the Board of Notaries, on the 12th of December following (1928), under No. 1874;

That, in the month of June, 1929, he left the office of Mtre. John Fair to continue his clerkship in the office of Mtre. Henri Schetagne, until the 22nd of December, 1932;

That, from the 22nd of December, 1932, till the month of May, 1935, he continued his clerkship with Mtre. J. M. Taillon, notary, at Montreal;

That, since the month of May, 1935, to date, he has attended and still attends the office of Mtre. D. Trudel, notary at Laprairie;

That, starting from the month of June, 1929, date of his leaving Notary Fair, he has omitted obtaining the transfers of articles required by section 218 of the Notarial

Code, not deeming them necessary through erroneous information;

That the certificates of clerkship obtained by him are through such omission of no effect;

That, as against this, he has more than fulfilled the requirements of section 221 of the Notarial Code (Revised Statutes of Quebec, 1925, chapter 211), as he has to his credit an uninterrupted clerkship of ten years, as his certificates prove;

That he desires to undergo his examination for admission to the practice of the notarial profession at the next session of the Board of Notaries, in July, 1938, or at any subsequent session;

That, in order to do so, it is desirable to validate the stages of clerkship served by him starting from the month of June, 1929, to date, and thus render effective the certificates of clerkship obtained by him, so that the said Jacques Feeney may afterwards be admitted to the practice of the notarial profession, after examination;

That the Board of Notaries of the Province of Quebec, through its Council, at its sitting of the 23rd of February, 1938, has given its consent to the presenting of a Bill to such effect; and

Whereas it is expedient to grant the prayer contained in the said petition;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. The clerkship of Jacques Feeney, notarial student, of the town of Laprairie, shall be deemed valid, notwithstanding that from the month of June, 1929, to date, he did not have his articles of clerkship transferred to each different patron whom he had; and shall avail to authorize the Board of Notaries to admit him to the practice of the notarial profession, after examination.

Coming into

2. This act shall come into force on the day of its sanction.
