



CHAPTER 70

An Act to create the Roman Catholic and Protestant school municipalities of the town of Val d'Or

[Assented to, the 27th of May, 1937]

HIS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. Notwithstanding any law or proclamation, the school municipalities of the town of Bourlamaque and of the village of Val d'Or, in the electoral district of Abitibi, are abolished and, in the same district, a Roman Catholic school municipality under the name of "Roman Catholic school municipality of Val d'Or", and a Protestant school municipality under the name of "Protestant school municipality of Val d'Or" are erected; such municipalities shall comprise:

The territory situated partly in the township of Dubuisson and partly in the township of Bourlamaque, containing the town of Bourlamaque, the town of Val d'Or and the unorganized area of land held by the company called "Sigma Mines Limited" in the township of Bourlamaque, such territory being more particularly described as follows: beginning at the point of intersection of the line separating the townships of Bourlamaque and Dubuisson with the line separating the seventh and eighth ranges of the township of Dubuisson, thence, passing successively by the following lines and bounds: in the township of Dubuisson, the said line separating the seventh and eighth ranges as far as the western line of the lot No. 59 of the eighth range, the said western line of lot No. 59 of the eighth

range, the western line of lot No. 59 of the ninth range in two fragments connected by the shore of Lake Blouin, as far as the line separating the ninth and tenth ranges, the latter line as far as Lake Blouin and its prolongation into the lake to the prolongation of the line separating the townships of Bourlamaque and Dubuisson, the latter prolongation and the said line separating the townships of Bourlamaque and Dubuisson to its point of intersection with the line separating the eighth and ninth ranges of the township of Dubuisson, thence, in the township of Bourlamaque, a straight line joining the point lastly described to the summit of the most northwestern corner of Block 34, the northern boundaries of the Block 34 and of the mining claims A-44066, A-44054, A-44055, A-44056, A-44057, the northern and eastern boundaries of the claim A-44065, the northern boundary of claim A-36597, the northern and eastern boundaries of claim A-36600, the eastern boundary of claim A-36601, the northeastern boundary of claim A-39160, the northern and eastern boundaries of claim A-39159, the northern boundaries of the claims A-39158, A-39157, A-39156, the northern, eastern and southern boundaries of claim A-39155, the southern boundaries of claims A-39156, A-39157, A-39158, A-39867, and A-39866, the eastern boundary of claim A-26181, the northern, eastern and southern boundaries of claim A-40132, the southern boundaries of claims A-36603, A-36604, A-36605, A-36606 and A-36607, the southern and western boundaries of claim A-36608, the southern boundaries of blocks 26, 27 and 28, the western boundaries of blocks 28, 29, 18 and 21 as far as the extension through block 14 of the line separating the seventh and eighth ranges of the township of Dubuisson and finally the said last mentioned extension to the starting point; the whole as surveyed and marked on the plans kept in the archives of the survey bureau and of the Bureau of Mines.

Dividing of
assets, etc.

2. The new school corporations, respectively, according to the proportion determined by the Superintendent of Education, shall divide all the assets and all the liabilities of the two school corporations hereby abolished.

Election of

3. The election of the school commissioners of the corporations hereby created shall be held by secret ballot and the said corporations shall be governed by

the Education Act (Revised Statutes, 1925, chapter 133) except where inconsistent with the provisions of this act.

4. This act shall come into force on the first day of ^{Coming into} July, 1937. _{force.}
