



CHAPTER 115

An Act to amend the charter of the town of Lasalle

[Assented to, the 20th of May, 1937]

WHEREAS the town of Lasalle has, by its petition, Preamble.
represented that it is in the interest of the good
administration of its affairs that its charter, the act 2
George V, chapter 73, as amended by the acts 3
George V, chapter 69; 5 George V, chapter 98; 7
George V, chapter 75; 10 George V, chapter 101; 12
George V, chapter 112; 15 George V, chapters 100 and
101; 18 George V, chapter 104; 20 George V, chapter
116; 22 George V, chapter 117, and 25-26 George V,
chapter 130, be again amended for the purposes of
limiting the valuation of cultivated and uncleared lands;
of exempting the ratepayers of the town from payment
of the cost of the acquisition by the city of Montreal of
the immoveables required for the construction of
boulevards on each side of its waterworks' canal; of
increasing its powers of taxing business carried on by
outsiders; of granting licenses for bicyclists; and

Whereas it is expedient to grant its prayer;

Therefore, His Majesty, with the advice and consent
of the Legislative Council and of the Legislative
Assembly of Quebec, enacts as follows:

R. S., c. 102, s. 522, replaced for town. **"19.** Section 522 of the Cities and Towns' Act (Revised Statutes, 1925, chapter 102) is replaced, for the town, by the following:

Valuation of certain land. **"522.** Any land under cultivation or farmed or used as pasture for cattle, as well as any uncleared land or wood lots within the town, shall not be valued at more than one hundred dollars per arpent counting from the first of January, 1938.

Comprised in valuation. The said valuation shall include the barns, stables and other buildings used for the said land, excluding the houses which shall be valued at their real value.

Additions to valuation roll. The council may cause at any time to be added to the valuation roll, by the assessors in office, according to the estimate made by them, any part of such land which has been detached as a building lot and has thus become liable to the tax, after the valuation roll has been closed, and may exact the tax as in the case of all other lands entered on the said roll."

Licensing of bicycles. **2.** The town council may make by-laws for granting annual licenses to residents using bicycles in the streets of the municipality and compel them to take out a number for each bicycle, the cost of the license not to exceed one dollar.

Taxation for certain non-resident traders. **3.** Traders in oil, gasoline, soft drinks, sweets, confectionery, pastry, tobacco or other merchandise, not residing in the town, but bringing with them their merchandise not previously sold and delivering same to their clients or purchasers in the town, shall be subject to the duties, taxes or licenses which may be imposed by the town under the authority of paragraph 12 of section 469, and of section 526, of the Cities and Towns' Act (Revised Statutes, 1925, chapter 102).

Freeing of certain immoveables from certain levy. **4.** Notwithstanding any law, by-law, order, resolution or assessment roll to the contrary, no part of the cost of purchase by the city of Montreal of the immoveable property required for the widening of the Montreal waterworks' canal or for the construction of boulevards on each side of the said canal shall be levied on the immoveables situated within the territory of the town of Lasalle, nor exigible from the owners of the said immoveables.

5. Section 1 of this act shall come into force on the Coming into
1st of January, 1938, and the other sections of this act ^{force.}
shall come into force on the day of its sanction.
