



## CHAPTER 7

An Act respecting public monies in relation to the Legislative Council and the Legislative Assembly

*[Assented to, the 12th of November, 1936]*

HIS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

1. Section 46 of the Legislature Act (Revised Statutes, 1925, chapter 3) is replaced by the following: R. S., c. 3, s. 46, replaced.

"46. The sums of money voted by the Legislature upon such estimates, or payable to the members for their indemnity and travelling expenses, and to the Speaker and Deputy Speaker for their salary, shall be paid over to and held by the Provincial Treasurer subject to the order of the commissioners or any three of them, of whom the Speaker shall be one." Payment on order of commissioners.

2. Section 48 of the said act is replaced by the following: R. S., c. 3, s. 48, replaced.

"48. Every payment out of the sums enumerated in section 46 shall be made by the Provincial Treasurer, by means of an order signed by the Speaker and two other commissioners." How payments made.

3. Section 49 of the said act is replaced by the following: R. S., c. 3, s. 49, replaced.

"49. If the sums voted by the Legislature for any fiscal year be more than sufficient to pay all charges, the surplus shall be paid into the consolidated revenue fund to form part of such fund." Disposal of surplus.

**4.** Section 83 of the said act is amended by replacing the words: "clerk of the Legislative Council or the accountant of the Legislative Assembly, as the case may be", in the fourth, fifth and sixth lines thereof, by the words: "Provincial Treasurer".

**5.** Section 88 of the said act, as amended by the act 19 George V, chapter 16, section 2, is again amended by adding thereto, after the word: "paid", in the last line of the second paragraph thereof, the words: "by the Provincial Treasurer. Nevertheless, the Provincial Treasurer shall from time to time remit to the accountant of the Legislative Assembly, in so far as the indemnity of the deputies is concerned, and to the clerk of the Legislative Council, in so far as the indemnity of the Legislative Councillors is concerned, the sums necessary to pay forthwith the indemnities due to the members of the Legislative Assembly and of the Legislative Council".

**6.** Section 89 of the said act is amended:  
*a.* By striking out the words: "to the clerk of the Legislative Council," in the fourth line thereof;  
*b.* By striking out the word: " , respectively," in the fifth line thereof.
