



CHAPTER 3

An Act to amend the Territorial Division Act respecting the county municipality of Temiscouata

[Assented to, the 10th of June, 1936]

HIS MAJESTY, with the advice and consent of the
Legislative Council and of the Legislative Assembly
of Quebec, enacts as follows:

1. Paragraph 5 of section 4 of the Territorial Division R. S., c. 2, Act (Revised Statutes, 1925, chapter 2), as amended by s. 4, § 5, am. the act 22 George V, chapter 14, sections 2 and 9, is again amended by replacing the word: "seventy-five", in the third line thereof, by the word: "seventy-six".

2. Section 17 of the said act, as amended by the act 22 Id., s. 17, George V, chapter 14, sections 6 and 9, is again amended: ^{am.}

a. By replacing the word: "seventy-five", in the first line thereof, by the word: "seventy-six";

b. By adding thereto, after paragraph No. 58 of the Table of County Municipalities, the following paragraph:

"58a	Rivière-du-Loup....	<p>1. The electoral district of Rivière-du-Loup, less the city of Rivière-du-Loup (1 Geo. V, (1910), c. 56; 9 Geo. V, c. 100) and the town of Trois-Pis-toles (6 Geo. V, c. 62), and excluding every part of the municipality of the township of Armand;</p> <p>2. The parish municipality of Notre-Dame-du-Portage in the electoral dis-trict of Kamouraska and Rivière-du-Loup.";</p>

c. By replacing paragraph No. 69 of the Table of County Municipalities by the following:

"69	Temiscouata.....	The electoral district of Temiscouata and including the whole of the municipality of the township of Armand."

3. From and after the date of the coming into force of this act the county municipality of Rivière-du-Loup shall have its chief place in the city of Rivière-du-Loup; and the county municipality of Temiscouata shall have its chief place in the parish municipality of Notre-Dame-du-Lac.

4. The first meeting of the county council of Temiscouata shall be held in the parish municipality of Notre-Dame-du-Lac, on the 7th of January, 1937, at ten o'clock of the forenoon, in the public hall.

Provisions

5. The provisions of the Municipal Code relating to the change of the limits of a municipality and to the obligations and rights of ratepayers shall apply to the county municipality the division whereof is enacted by this act and to the county municipalities created as a result of such division.

7. This act shall come into force on the 31st of December, 1936.
