



CHAPTER 23

An Act respecting the estate of the late Eusèbe Labelle

[Assented to, the 10th of June, 1936]

WHEREAS Eusèbe Labelle, Arthur Labelle and Joseph Labelle, all three of Pont Viau, and Rosa Labelle, wife of Charles Filiatrault, also of Pont Viau, personally and in her capacity of tutrix to the minor children of the late Alexandrine Labelle, in her lifetime wife of Andronic Gravel, and Rose Alba Labelle, spinster, of the age of majority, of the city and district of Montreal, all in their capacity of institutes in the substitution and heirs of the late Eusèbe Labelle, in his lifetime manufacturer, of Pont Viau, have, by their petition, represented: Preamble.

Labelle, all three of Pont Viau, and Rosa Labelle, wife of Charles Filiatrault, also of Pont Viau, personally and in her capacity of tutrix to the minor children of the late Alexandrine Labelle, in her lifetime wife of Andronic Gravel, and Rose Alba Labelle, spinster, of the age of majority, of the city and district of Montreal, all in their capacity of institutes in the substitution and heirs of the late Eusèbe Labelle, in his lifetime manufacturer, of Pont Viau, have, by their petition, represented:

That it is expedient to amend the act 23 George V, chapter 165, to continue payment of the rent stipulated in their favour, until the final partition of the property of the estate of the said late Eusèbe Labelle;

That such rent was stipulated in their favour to enable them to live;

That the revenues from the property of the said estate are insufficient to permit the petitioners to provide for their subsistence and maintenance and that of their children the substitutes in the said substitution;

That their financial condition has not improved since the passing of the said act;

That, since the passing of the act 23 George V, chapter 165, one of the institutes has died leaving three children, two of whom are minors represented by their tutrix Dame Rosa Labelle, wife of Charles Filiatrault; and

Whereas it is expedient to grant their prayer and pass an act for such purpose;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

23 Geo. V, c. 165, s. 2, replaced.
1. Section 2 of the act 23 George V, chapter 165, is replaced by the following:

Payments to certain legatees authorized.
“**2.** The said General Trust of Canada is authorized to pay to each of the institute legatees, or to their children by root in case of death of one or the other of the said legatees, from the capital of the estate, the sum of six hundred dollars per annum, payable in monthly instalments of fifty dollars each, and this until the final division of the property of the estate, as provided in the will of the late Eusèbe Labelle.”

Costs of act.
2. The estate shall pay the costs, disbursements and fees incurred for the passing of this act, and the testamentary executors shall deduct the amount thereof from the capital of the estate.

Coming into force.
3. This act shall come into force on the day of its sanction.
