CONCERNING THE CLASSIFICATION OF GASOLINE

IT IS ORDERED that the testing methods to determine the different grades of gasoline be the ones prescribed by the National Research Council of Canada, and that the method to determine the octane number of gasoline be the one known as the CFR motor method.

IT IS FURTHER ORDERED that wherever there is mention of "octane" in the Order in Council No. 1471 of the 6th of June, 1935, it shall mean "octane number".

THEREFORE, IT IS ORDERED, that the hunting season for deer, within the limits of the Little Nation Seigniory, shall open on the 1st of October to close on the 30th of November, and that the Order in Council No. 481, dated February 16th, 1935, be amended accordingly.

WHEREAS it is expedient to grant the said petitions to a certain extent, whilst maintaining the restriction of the hunting season to two months;

THEREFORE, IT IS ORDERED, that, in future, the hunting season for deer in all the counties situate north of the Saint Lawrence River, excepting in the "Petite Nation" Seigniory, shall begin on the 20th of September and end on the 20th of November of each year, and that Order in Council No. 481, dated February 16th, 1935, be amended accordingly.

CONCERNING THE PRICE OF LICENSES FOR HUNTING
FURBEARING ANIMALS, FOR THE RESIDENTS OF

WHEREAS the price of \$5.00 for the licenses for hunting fur-bearing animals for the residents of the Province, which was fixed by an Order in Council on August 22nd, 1928, is actually too high considering the considerable decrease in the value of pelts;

THEREFORE, IT IS ORDERED, that the price of the said licenses, for the future, be only \$2.00 instead of \$5.00 which is the present price, for the residents of the Province of Quebec, and that the Order in Council No. 1549 of August 22nd, 1928, be amended accordingly.

CONCERNING THE SALE OF PARTRIDGE

WHEREAS section 10 of chapter 86 of the Revised Statutes of Quebec (1925) stipulates that the purchase, sale or possession with intent to sell, of any birch or spruce partridge, as well as sharp-tailed grouse, shall end on the 1st of October, 1935, and whereas it is expedient to further extend this prohibition for several years;

THEREFORE, IT IS ORDERED, that pursuant to paragraph 2 of section 48 of the Game Laws (Revised Statutes 1925. chapter 86), the prohibition of the purchase, sale, exposing for sale, possession with intent to sell, of birch or spruce partridge and sharp-tailed grouse, be extended for a further period of three years.

PRESENT: THE LIEUTENANT-GOVERNOR IN COUNCIL

RESPECTING THE COLLECTION OF A ROYALTY ON MINK
REARED IN CAPTIVITY

WHEREAS by Order in Council dated February 26th, 1935, it was enacted that all furs put on the market be subject to a royalty, with the exception of silver fox and black fox pelts from animals reared in captivity;

WHEREAS it is expedient also to make an exception for mink, skins from animals reared in captivity, or likewise for mink reared in the same manner:

THEREFORE, IT IS ORDERED, that mink pelts or domestic mink, shipped to the markets or elsewhere, be exempt from the royalty, provided that such shipments be accompanied with a sworn declaration, the form whereof to be approved and furnished by the Minister of Public Works, Game and Fisheries; and that the Order in Council No. 523, dated February 26th, 1935, be amended accordingly.

CONCERNING THE MOTOR VEHICLE ACT, R.S.Q., (1925)
CHAPTER 35

WHEREAS under paragraph *b* of subsection 1 of section 68 of the Motor Vehicle Act, R. S. Q., (1925) Chapter 35, the Lieutenant-Governor in Council may alter the maximum weight, load included, and the maximum speed of autobusses, commercial vehicles and delivery cars, when used on all or certain public highways and in all or certain localities;

THEREFORE, IT IS ORDERED:

That, notwithstanding subsection 3 of section 40 of the said Motor Vehicle Act, the maximum total weight allowed for autobusses operated on the public highways of the Province shall be 22,000 pounds, provided, however, that the weight on any one wheel does not exceed five hundred pounds per inch width of its tire and that the weight on any one axle be not in excess of 15,000 pounds;

That the maximum total weight for autobusses operated on public highways Nos. 2, 7 and 14, from Montreal to the boundary line of Ontario and of the United States, shall be 25,000 pounds, provided, however;

1. That the wheelbase be not less than 250 inches;
2. That the total maximum weight for any one wheel does not exceed 500 pounds per inch width of tire;
3. That the weight on the rear axle be not in excess of 15,000 pounds;
4. That the front wheels be fitted with special tires, so that the weight per inch width on these tires be not in excess of 500 pounds;

That Order in Council No. 860, dated April 21st, 1934, approved by the Lieutenant-Governor on the 24th of April, 1934, and published in the *Quebec Official Gazette* on the 28th of April, 1934, and Order in Council No. 435, dated the 12th of February, 1936, approved by the Lieutenant-Governor on the 14th of February, 1936, be both revoked.

CONCERNING THE TARIFF OF FEES PAYABLE TO
THE PUBLIC SERVICE COMMISSION

WHEREAS the Lieutenant-Governor in Council has made a tariff of fees payable to the Public Service Commission, on certain appropriations, by Order in Council No. 703, dated April 30th, 1926;

WHEREAS such tariff was amended by Order in Council No. 1341 of August 11th, 1927; by Order in Council No. 1258 of June 2nd, 1932, and by Order in Council No. 2678 of November 8th, 1932;

WHEREAS it is expedient to further amend such tariff;

THEREFORE, IT IS ORDERED:

That the tariff of fees payable to the Public Service Commission be amended by adding at the end of Article 3, the following:

“For every renewal of certificate of permit, per annum. . . \$10.00”

That the amendment ordered by the present Order in Council take effect from January 1st, 1936.

CONCERNING THE PRICE OF PERMITS TO HUNT
FEATHERED GAME

WHEREAS the Order in Council dated January 31st, 1934, fixes the price of the permits to fish and hunt for all non-residents of the Province, as well as the permits to transport game for residents;

WHEREAS the hunting permit of \$26.00 for non-residents not members of a club and that of \$10.50 for non-residents *bona fide* members of a club, are issued for all species of game;

WHEREAS it is well known that quite a number of non-residents come into the Province to hunt feathered game exclusively, particularly in the Southern region of the Province and that it is expedient to make a distinction in the price of hunting permits for those non-residents who limit themselves exclusively to feathered game;

THEREFORE, IT IS ORDERED, that a special hunting permit for feathered game be issued to all non-residents who come to hunt such game in our Province, and that the price of such permit be fixed at \$15.00, plus \$0.50 commission, and that the Order in Council above cited, bearing No. 188, be amended accordingly.

EXECUTIVE COUNCIL CHAMBER

PRESENT: THE LIEUTENANT-GOVERNOR IN COUNCIL

CONCERNING THE PROTECTION OF HUNGARIAN
PARTRIDGE

WHEREAS, for several years, people have imported Hungarian Partridge into the Province for the purpose of freeing the said birds in the woods with a view to reproduction and whereas in the month of April, 1931, a regulation was passed prohibiting the hunting of same for a period of five years;

WHEREAS this period expires on the 1st of May, 1936, and it is expedient to further extend it;

THEREFORE, IT IS ORDERED, that it be prohibited, at all times, to hunt, kill or take Hungarian Partridge, or to disturb, damage, gather or take the eggs of such birds, for a further period of five years, namely from the 1st of May, 1936, until the 1st of May, 1941.

EXECUTIVE COUNCIL CHAMBER

PRESENT: THE LIEUTENANT-GOVERNOR IN COUNCIL
RESPECTING THE TRAVEL PERMIT ON CROWN LANDS
BETWEEN MAY 30TH AND NOVEMBER 15TH, 1936

WHEREAS, for the protection of the forests against fire, it is expedient to enforce the provisions of section 144 of the Lands and Forests Act (Revised Statutes 1925, chapter 44), respecting the Travel Permit;

WHEREAS experience has shown that the enforcement of such a measure was efficacious and that it might be employed during this season;

THEREFORE, IT IS ORDERED, that anyone wishing to enter the forest, during the period between the 30th of May and the 15th of November of the same year, shall previously obtain a travel permit, as required under section 144 of the Lands and Forests Act (Revised Statutes 1925, chapter 44), and show same to any fire warden when requested to do so.
