



CHAPTER 5

An Act respecting the establishing of one or more cold storage warehouses, for fishing purposes

[Assented, to the 11th of April, 1935]

WHEREAS it is expedient to construct and establish one Preamble.
or more cold storage warehouses, for the purpose of
furnishing fishermen with the means of preserving fish and

Therefore, His Majesty, with the advice and consent of
the Legislative Council and of the Legislative Assembly of
Quebec, enacts as follows:

The Lieutenant-Governor in Council may, if he deem it Loan au-

ize the Provincial Treasurer to contract a loan or loans, by means of bonds or inscribed stock issued on the credit of the Province.

Interest
thereon, etc.

Such bonds or inscribed stock shall be issued at the rate of interest, for the term, in the form and for the amount which the Lieutenant-Governor in Council may determine, and shall be payable, in interest and principal, at the time and places which he may indicate.

Acquisitions
authorized.

3. In order to procure the land required for the construction, establishment or furnishing of such cold storage warehouse or warehouses, the Lieutenant-Governor in Council is authorized to acquire, by agreement or expropriation, the necessary immoveable properties and every immoveable right, charge, lease for occupation or emphyteutic lease, constituted rent, or other rights affecting such immoveable properties.

Provisions
applicable.

Every expropriation necessitated for the purposes of this act shall be governed by the Quebec Railway Act, (Revised Statutes, 1925, chapter 230), *mutatis mutandis*.

Certificate
may replace
guarantee.

The judge may, in granting previous possession of the required land, accept, instead of the guarantee exigible under subsection 3 of section 112 of the said Quebec Railway Act, a certificate from the Provincial Treasurer, stating that he holds the amount fixed at the disposal of the court.

Carrying
out of act.

4. The Minister of Public Works is charged with the carrying out of this act.

Coming into
force.

5. This act shall come into force on the day of its sanction.
