



CHAPTER 127

An Act to amend the charter of the town of La Tuque

[Assented to, the 18th of May, 1935]

WHEREAS the corporation of the town of La Tuque Preamble.
has represented by its petition that it is expedient, in the interest of the ratepayers and for the proper administration of its affairs, that its charter, the act 1 George V (2nd session), chapter 69, as amended by the acts 2 George V, chapter 70; 4 George V, chapter 86; 11 George V, chapter 122, and 13 George V, chapter 99, be again amended for the following purposes, namely:

To annex to the town a certain territory to make the northern and southern boundaries of the town uniform on both sides of the river St. Maurice; to determine the valuation of the taxable immoveables belonging to the St. Maurice Power Corporation, Limited, situate in the territory to be annexed;

Whereas the said annexation is made at the request of the town of La Tuque, of La Tuque School Commission and of the Quebec Municipal Commission, the whole in the interest of the said municipality and commissions; and

Whereas it is expedient to grant the prayer of the said petition;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. The act 1 George V (2nd session), chapter 69, is amended by inserting therein, after section 1 thereof, the following section: 1 Geo. V (1911), c. 69, s. 1a, added.

Annexing of certain territory to town of La Tuque. Territory affected.

1a. The following territory, forming part of the electoral district of Laviolette, is annexed to the town of La Tuque, namely:

Lots Nos. 18, 19, 20, 21 and 22 of the first range of the township of Vallières; the bed of the river St. Maurice, in front of the five last-mentioned lots, and the said bed by descending the course of the river to the prolongation of the line separating lot No. 25 from lot No. 26 of the first range, in each of the townships of Vallières and Mailhot; the bed of the river Bostonnais, at its outlet into the river St. Maurice, as far as the northern line of lot No. 18 in each of the two aforesaid townships, extended to the left bank of the said river Bostonnais, the whole comprised within the high water marks of the said rivers, with the islands included within the limits thus determined."

Ward No. 3. **2.** Such territory shall form part of ward No. 3.

Fixed valuation of certain immoveables.

3. All taxable immoveables belonging to the St. Maurice Power Corporation, Limited, situate in the territory hereby annexed to the town of La Tuque, shall be entered in the valuation roll for municipal and school purposes at a sum of fifteen thousand dollars.

Duration of such fixed valuation.

4. The provisions of section 3 of this act shall remain in force only so long as no taxable constructions or improvements are made, but, after ten years, if no taxable constructions and improvements have been made, the taxable immoveables of the company must be valued at the same real estate value as that of neighbouring lots, for as long as such taxable constructions or improvements are not made.

Ile-aux-Goélands and town of La Tuque.

5. Ile-aux-Goélands shall form and shall be considered to have always formed part of the territory of the town of La Tuque; and this provision is to remove the ambiguity in this connexion arising from the fact that the island is not expressly described in the aforesaid act.

Application of ss. 3 and 4.

6. Sections 3 and 4 of this act shall apply to the Ile-aux-Goélands.

Coming into force.

7. This act shall come into force on the day of its sanction.
