



CHAPTER 133

An Act to confirm and ratify certain deeds and by-laws
passed by the town of Ste. Thérèse

[Assented to, the 18th of May, 1935]

WHEREAS the town of Ste. Thérèse has, by its petition, Preamble.
represented that the validity of the hereinafter mentioned deeds, agreement and by-laws has been questioned, and should be confirmed and ratified;

That the said deeds, agreement and by-laws were made for the purpose of promoting work within the territory of the town, and to relieve unemployment; and

Whereas it is expedient to grant the prayer contained in the said petition;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. The deeds, agreement and by-laws, hereinafter mentioned, are confirmed, ratified and declared valid for all legal purposes, namely: Deeds, etc.,
validated.

a. By-law No. 127, adopted on the 12th of November, 1932, by the council of the town of Ste. Thérèse;

b. By-law No. 132, adopted on the 6th of November, 1933, by the council of the town of Ste. Thérèse;

c. An agreement entered into between the town of Ste. Thérèse and Pollock Brothers & Company, Limited, on the 17th of June, 1933, at Ste. Thérèse, before Notary J. L. Blanchard;

d. A deed of sale entered into by the town of Ste. Thérèse with Pollock Brothers & Company, Limited, on the 17th of June, 1933, before Notary J. L. Blanchard, at Ste. Thérèse, registered in the registration office of Terrebonne under No. 105785;

e. A deed of sale entered into by the town of Ste. Thérèse with Ernest Thibault, on the 13th of October, 1934, before Notary J. L. Blanchard, at Ste. Thérèse, registered in the registration office of Terrebonne, under No. 108238:

f. A deed of sale entered into by J. A. Laurin, Limitée, with the town of Ste. Thérèse, on the 8th of March, 1934, at Ste. Thérèse, before Notary J. L. Blanchard, registered in the registration office of Terrebonne, under No. 106919.

2. The action taken by one Antonio Forget against the municipality of the town of Ste. Thérèse, in the Superior Court of the district of Terrebonne, bearing No. 5446 of the records of such Court, asking for the cancellation of the deed of sale entered into by the town of Ste. Thérèse with Pollock Brothers & Company, Limited, on the 17th of June, 1933, is discontinued, but the town of Ste. Thérèse must pay the costs of the said action.
