



## CHAPTER 139

An Act to incorporate the municipality of the parish of St.  
Denis de Brompton, in the county of Richmond

*[Assented to, the 6th of March, 1935]*

**W**HEREAS Ferdinand Bouffard, Alfred Lamontagne Preamble.  
and many other ratepayers constituting the majority  
of the inhabitants of the parish of St. Denis de Brompton,  
partly situated in the county of Richmond and partly in  
the county of Sherbrooke, have, by their petition, prayed  
that the said parish be erected into a separate local muni-  
cipality;

Whereas the population of the territory to be erected into  
a parish municipality is at least three hundred souls; and

Whereas it is expedient to grant such prayer;

Therefore, His Majesty, with the advice and consent of  
the Legislative Council and of the Legislative Assembly of  
Quebec, enacts as follows:

**1.** The parish of St. Denis de Brompton, situated in the Incorpora-  
municipalities of the township of Brompton, of the parish tion.  
of St. François Xavier de Brompton, of the parish of St.  
Elie d'Orford and of the township of Orford, shall hence-  
forth form a local municipality situated entirely in the  
county of Richmond, under the name of "municipality of Name.  
the parish of St. Denis de Brompton".

The territory of the municipality shall consist of the Territory.  
two-thirds northwest of lot one of range seven and of lots  
one of ranges eight and nine, one to nine inclusively of  
ranges ten, eleven, twelve and thirteen of the township  
of Orford, in the electoral district and county of Sherbrooke,  
and of lots ten to twenty-four inclusively of range seven,  
twenty-four to thirty-six inclusively of range eight, twenty-  
four to thirty-two inclusively of range nine, and twenty-

seven and twenty-eight of range ten of the township of Brompton, in the electoral district and county of Richmond.

Where municipality to be situate.

**2.** The municipality of the parish of St. Denis de Brompton shall be entirely situate in the electoral district and county of Richmond whereof it shall form part for all electoral, municipal, judicial or other purposes whatsoever, except registration purposes, and the municipality shall be governed by the Municipal Code of the Province of Quebec, except where inconsistent with this act.

First election.

**3.** The first election in the municipality shall be held on the day fixed by the Minister of Municipal Affairs and be presided over by the person appointed for the purpose by the Minister of Municipal Affairs and all the articles of the Municipal Code of the Province of Quebec relating to elections and meetings of the municipal electors shall apply, *mutatis mutandis*, to the first election of the mayor and councillors.

Electoral qualifications.

**4.** The valuation rolls of the said municipalities of the township of Brompton, parish of St. François Xavier de Brompton, parish of St. Elie d'Orford and township of Orford, shall serve as the basis for the electoral qualifications of the municipal electors for the said first election.

Valuation rolls, etc., to remain in force.

**5.** The valuation rolls, electors' lists, *procès-verbaux*, apportionments, by-laws and other documents formerly governing the territory hereby erected into a separate local municipality, shall continue to apply to such territory until amended, repealed or replaced by competent authority, and certified copies of such documents relating to the said municipality shall be legal and authentic and be proof of their contents for all legal purposes.

Costs of act.

**6.** The costs, fees and disbursements incurred for the passing of this act shall be paid by the municipality of the parish of St. Denis de Brompton.

Coming into force.

**7.** This act shall come into force on the day of its sanction.
