



CHAPTER 52

An Act to amend the Pipe-fitters Act

[Assented to, the 20th of April, 1934]

HIS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. The title of the Pipe-fitters Act (Revised Statutes, R. S., c. 1925, chapter 176A), as enacted by the act 23 George V, ^{176A, title} chapter 69, is amended by replacing the words: "**PIPE-FITTERS**", by the words: "**PIPE-MECHANICS**".

2. Section 1 of the said act is amended by replacing the Id., s. 1, am. word: "*Pipe-fitters*", in the first line thereof, by the word: "*Pipe-Mechanics*".

3. Section 2 of the said act is amended:

a. By adding thereto, after the word: "corporation", in the second line of paragraph 2 thereof, the words: "who or which employs journeymen or apprentices, as described in paragraphs 3 and 4 of this section, or";

b. By adding thereto, at the end of sub-paragraph *a* of paragraph 2 thereof, the words: "and likewise any firing system";

c. By adding thereto, after the word: "sprayers", in the first line of sub-paragraph *c* of the said paragraph 2 thereof, the words: "utilized to prevent and fight fires in any building or construction";

d. By adding thereto, after the said sub-paragraph *c* of the said paragraph 2 thereof, the following sub-paragraph:

"*d.* Plumbing systems, in any building or construction, ^{Plumbing} including piping and all accessories used for drainage or ^{systems.} draining; for the back air vent; for supplying hot or cold water or gas;"

e. By replacing the word and letter: "and *c*", in the fifth line of paragraph 3 thereof, by the word and letters: ", *c* and *d*";

f. By replacing the word and letter: "and *c*", in the fourth line of paragraph 4 thereof, by the word and letters: ", *c* and *d*".

4. Section 3 of the said act is amended by replacing the word and letter: "and *c*", in the sixth line of the first paragraph thereof, by the word and letters: ", *c* and *d*".

5. The said act is amended by inserting therein, after section 5 thereof, the following sections:

Persons, etc.,
exempt from
application
of certain
provisions.

"**5a.** However, contractors, journeymen and apprentices engaged in the work specified in sub-paragraph *d* of paragraph 2 of section 2 shall not be subject to the provisions of section 5, if the municipality in which they reside, by a by-law adopted before the 20th of April, 1934, already subjects them to a license after an examination as to their technical qualification.

The licenses issued for such contractors, journeymen and apprentices, contemplated in the preceding paragraph, shall be valid only within the territory of the said municipality.

"**5b.** The provisions of section 5 shall apply even in a municipality of ten thousand souls or less, if the work specified in sub-paragraphs *a*, *b*, *c* and *d* of paragraph 2 of section 2 be performed in public buildings or industrial establishments, as defined in paragraphs 5 and 6 of section 2 of the Pressure Vessels Act (Chap. 182A)."

6. Section 7 of the said act is amended by adding thereto, after paragraph 2 thereof, the following paragraph:

Contractor's
license.

"Notwithstanding paragraphs 1 and 2 of this section, a contractor's license can only be granted to a contractor actually having an office and workshop, so considered by the board of examiners."

7. Section 10 of the said act is amended by replacing the word and letter: "and *c*", in the third line thereof, by the word and letters: ", *c* and *d*".

8. Section 12 of the said act is amended by replacing the word and letter: "and *c*", in the fifth line of the first paragraph thereof, by the word and letters: ", *c* and *d*".

9. Section 15 of the said act is amended by replacing R. S., c. the word and letter: "and c", in the fourth line of the first ^{176A, s. 15,} paragraph thereof, by the word and letters: ", c and d". ^{am.}

10. Section 27 of the said act is replaced by the fol- ^{Id., s. 27,} lowing: ^{replaced.}

"**27.** Notwithstanding any provision to the contrary ^{Persons,} in this act, no person, company, association or corporation ^{etc., ex-} who or which does business as a contractor, and no one ^{cluded from} working as a journeyman or apprentice, shall be subject ^{application} to the provisions of this act if the work which he or it con- ^{of act.} tracts for or does is work done on locomotives, railway cars or ships."

11. Section 28 of the said act is amended by replacing R. S., c. the word and letter: "and c", in the fourth line thereof, by ^{176A, s. 28,} the word and letters: "c and d". ^{am.}
