



CHAPTER 7

An Act respecting the corporation of The Three Rivers Technical School

[Assented to, the 13th of April, 1933]

WHEREAS the Lieutenant-Governor in Council has Preamble.
guaranteed, in virtue of the acts 8 George V, chapter
42; 10 George V, chapter 44, and 12 George V, chapter 52,
the repayment of capital and interest on a total amount of
two hundred and fifty thousand dollars of debentures issued
by the corporation of The Three Rivers Technical School
under the aforesaid acts, and that two hundred thousand
dollars of the said debentures have been redeemed and
cancelled to date, leaving a balance of only fifty thousand
dollars unpaid;

Whereas the said fifty thousand dollars of debentures be-
came due on 1st of March, 1932, and it is necessary to
guarantee, for a term of not more than twenty-five years, a
new issue of debentures of the corporation of The Three
Rivers Technical School to redeem such loan which has
been authorized and the payment whereof has been guaran-
teed by the acts above-mentioned;

Whereas the corporation of The Three Rivers Technical
School is not in a position to negotiate a new loan unless
same be guaranteed by the Government; and

Whereas it is in the public interest that such guarantee
be given;

Therefore, His Majesty, with the advice and consent of
the Legislative Council and of the Legislative Assembly of
Quebec, enacts as follows:

1. The corporation of The Three Rivers Technical School Loan au-
is hereby authorized to contract a new loan not exceeding thorized.
fifty thousand dollars at a rate of interest of not more than

five per cent per annum and for a period not exceeding twenty-five years, the proceeds of which shall be used to redeem the loan due on the 1st of March, 1932.

2. The Lieutenant-Governor in Council is authorized to guarantee the payment of the capital and interest at a rate not exceeding five per cent per annum of the new loan of fifty thousand dollars for a period not exceeding twenty-five years, mentioned in this act, on the conditions which he may deem suitable.

3. In consideration of the fact that the Government of the Province of Quebec has furnished the sums necessary for the redemption and cancellation of the amount of two hundred thousand dollars of the total of two hundred and fifty thousand dollars of debentures issued to provide for the construction and equipment of the said Three Rivers Technical School and that this act provides for the necessary guarantee as to the payment of the capital and interest of the said sum of fifty thousand dollars which remains unpaid, the corporation of the said Three Rivers Technical School shall sign, in favour of the Government, a deed of hypothec, to the satisfaction of the Lieutenant-Governor in Council, hypothecating its land and buildings situated in the said city of Three Rivers.

4. This act shall come into force on the day of its sanction.
