



CHAPTER 67

An Act to amend the Jury Act respecting Grand Jurors

[Assented to, the 13th of April, 1933]

HIS MAJESTY, with the advice and consent of the
Legislative Council and of the Legislative Assembly
of Quebec, enacts as follows:

"**49.** In every district, except the district of Montreal, the clerk of the Crown, or the clerk of the peace, as the case may be, before giving instructions to the sheriff to summon persons to serve as jurors, shall transmit to the Attorney-General a list of all the criminal cases to be tried at the next term or session of any court of criminal jurisdiction about to be held; and the clerk of the Crown or clerk of the peace shall not give instructions to the said sheriff to summon a jury for such term, unless authorized to do so by the Attorney-General." The jurors shall be summoned for the opening day of the term. Nevertheless, the Attorney-General may, if he think fit, in the interest of the good administration of justice, order the summoning of the jurors for another date, fixed by the authorization which he forwards to the clerk of the Crown or clerk of the peace, in accordance with the foregoing provisions, and, in such case, the clerk of the Crown or the clerk of the peace shall give instructions to the sheriff to summon the jurors for the date so fixed."
