



## CHAPTER 128

### An Act respecting the city of Shawinigan Falls

*[Assented to, the 15th of March, 1933]*

**W**HEREAS the city of Shawinigan Falls has, by its Preamble. petition, prayed for: ratification of its by-law No. 341 respecting the closing and sale of a portion of Transmission Avenue; power to change the site of another portion of the said street and to close a portion of Lambert street; ratification of a deed of sale of lot No. 624-223 to the Canada Carbide Co., Limited; ratification of its by-law No. 344 respecting the valuation of the industrial properties of Canadian Industries Limited; power to borrow a sum of sixty thousand dollars to cover its deficit on aid to the unemployed and another sum of forty thousand dollars for unemployment work, and annexation of certain lands contiguous to its territory;

Whereas the said city has represented that it is in the interest of its proper administration and progress to grant its prayer; and

Whereas it is expedient to grant its petition;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

**1.** By-law No. 341 of the city of Shawinigan Falls, dated the 17th of February, 1932, and the contract of sale, passed before Notary L. O. Baribeault, on the 4th of November, 1932, between the city of Shawinigan Falls and Shawinigan Chemicals Limited, and the property title of the said Shawinigan Chemicals Limited to the lands described in the said contract of sale, are ratified and confirmed. <sup>Validation of by-law, etc.</sup>

**2.** The city of Shawinigan Falls is authorized to change the site of that portion of Transmission Avenue which passes over the lots Nos. 624-197, 624-240 and 624-206 of the cadastre of Ste. Flore, to close it at that place, and to open it elsewhere and, for such purpose, to acquire the necessary land and to sell, cede or exchange the above-mentioned lots.

**3.** The city of Shawinigan Falls is also authorized to close the portion of Lambert street extending to the said Transmission Avenue, comprised between the latter and the track of the Canadian National Railway and situated on lot No. 624-201, and to sell, cede or exchange the said lot No. 624-201.

**4.** The contract of sale of lot No. 624-223 passed on the 23rd of January, 1917, before Notary Louis Z. Bertrand, between the town of Shawinigan Falls and the Canada Carbide Co. Limited, is confirmed, ratified and declared valid.

**5.** By-law No. 344 of the city of Shawinigan Falls is ratified and declared valid, and the valuation, for municipal purposes, of the taxable industrial properties of Canadian Industries Limited, as they existed at Shawinigan Falls on the 16th of May, 1932, is fixed at five hundred thousand dollars for ten years to be computed from the 1st of July, 1932; the said valuation shall not cover, however, the building used as offices and the additions then under construction for installing a second machine, which, as well as all extensions, improvements and additions made to the said properties since the said date of the 16th of May, 1932, or which may be made hereafter during the said period of ten years, shall be valued in the usual manner and their valuation shall be added, for municipal purposes, to the aforesaid valuation of five hundred thousand dollars.

**6.** The city of Shawinigan Falls is authorized to borrow a sum of sixty thousand dollars to cover its deficit on unemployment works, by means of a loan by-law subject to the approval of the Lieutenant-Governor in Council, and by an issue of bonds to be enacted by such by-law.

**7.** The city is authorized to borrow in the same manner another sum of forty thousand dollars for supplementary unemployment works.

**8.** Lots Nos. 39, 40, 43, 44, 45 and 46 of the cadastre of Ste. Flore are annexed to the city of Shawinigan Falls, for municipal purposes, and shall in future form part of the territory of the latter. Annexation of certain lots.

**9.** The electors of the school corporation of Shawinigan Falls shall be entitled to vote at the school elections without having previously paid their school taxes or assessments. Voting at school elections.

**10.** This act shall come into force on the day of its sanction. Coming into force.
