



CHAPTER 164

An Act respecting the estate of the late Rev. J. Charles Boutet, priest

[Assented to, the 15th of March, 1933]

WHEREAS the testamentary executors of the late Rev. Preamble.
J. Charles Boutet, in his lifetime priest, retired parish priest, of the city of Cap de la Madeleine, have, by their petition, represented:

That Rev. J. Charles Boutet, by his will received before J. A. Villeneuve, notary, on the 9th of June, 1927, No. 2137 of his originals, made the following legacy to the St. Joseph Seminary of Three Rivers:

"I give and bequeath to the St. Joseph Seminary of Three Rivers my building lot and my house and dependencies situated in the city of Cap de la Madeleine, as well as my oratory and the articles of worship therein contained, the whole of which I estimate at the sum of ten thousand dollars; such legacy being so made subject to the undertaking by the St. Joseph Seminary of educating, forever, a member of my family"; that such legacy was refused by the corporation of the St. Joseph Seminary of Three Rivers, as being more burdensome than profitable for it; that, on account of such renunciation, this particular legacy devolved upon the *Orphelinat St. Dominique* of Three Rivers, universal residuary legatee under the will; that the said institution cannot accept the said estate, with the above particular legacy, as too burdensome; and that, accordingly, the *Orphelinat St. Dominique* is deprived of several thousand dollars, representing the value of the universal residuary legacy made to it by the above-mentioned will;

Whereas the said testamentary executors have prayed for the passing of an act specifying more exactly clause 11 of the said will and allowing effect to be given thereto, while respecting the testator's wish; and

Whereas it is expedient to grant such prayer;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. The said clause 11 of the will of the late Rev. J. Charles Boutet, as inserted in the said will, is replaced by the following:

“11. I give and bequeath to the St. Joseph Seminary of Three Rivers my building lot and my house and dependencies, situated in the city of Cap de la Madeleine, as well as my oratory and the articles of worship therein contained, the whole of which I estimate at the sum of ten thousand dollars; such legacy being so made subject to the undertaking by the St. Joseph Seminary, or any other person called upon to receive it in its stead, to employ, until exhausted, the proceeds of the sale of the property forming the object thereof, with interest at three per cent per annum, for the education, at the St. Joseph Seminary of Three Rivers, of a member of my family to be chosen by the Superior of the said Seminary from amongst my nearest relatives.”
