



CHAPTER 17

An Act to annex certain territory to the municipality of
Sainte-Monique, in the county of Lake St. John-East

[Assented to, the 19th of February, 1932]

WHEREAS by proclamation of the 18th of March, 1931, Preamble.
the municipality of Jeanne-d'Arc, in the county
municipality of Lake St. John-East, has been considered as
non-organized territory;

Whereas such territory, according to the technical description of the Department of Lands and Forests, dated the 17th of December, 1931, is as follows:

"This territory in the township of Taillon, heretofore constituting the municipality of Jeanne-d'Arc, in the county municipality of Lake St. John-East, and now abolished by a proclamation of date the 18th of March, 1931, the boundaries whereof, referring strictly to those described by a resolution passed by the county council on the 9th of December, 1915, are as follows: towards the north, Peribonka river; towards the south and west, Lake St. John, and, towards the east, the western line of lot No. 28 of the sixth range and the lines between the lots numbers thirty, thirty-one (30, 31) of the fifth range and thirty-five, thirty-six (35, 36) of the second, third and fourth ranges, in the aforesaid township of Taillon.";

Whereas it is expedient to annex such territory to that of the municipality of Sainte-Monique, in the same county, and to establish special provisions respecting the apportioning of the cost of the present debts, of certain public works and of representation in the council of the municipality;

Whereas it is expedient to pass an act for such purposes;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. Paragraph No. 30 of the Table of the Electoral Districts in section 7 of the Territorial Division Act (Revised Statutes, 1925, chapter 2), as replaced by the act 20 George V, chapter 15, section 10, and amended by the act 21 George V, chapter 18, section 1, and replaced by the act 22 George V, chapter 16, section 5, is again amended by striking out the words and figures: "Jeanne-d'Arc (21 Geo. V, c. 18, s. 1)," in the twelfth and thirteenth lines of the third paragraph thereof.

2. The territory situate in the township of Taillon, in the county municipality of Lake St. John-East, described in the preamble to this act, is annexed to the municipality of Sainte-Monique to form part thereof.

Division
into two
districts.

3. From the date of the coming into force of this act, the municipality of Sainte-Monique shall be divided into two districts called: "District No. 1" and "District No. 2".

District
No. 1.

District No. 1 shall comprise the territory of the municipality of Sainte-Monique as it existed before the 19th of February, 1932; District No. 2 shall comprise the territory described in the preamble to this act.

District
No. 2.

Debts and
obligations.

4. The debts and obligations resulting from road work done wholly in one district shall be a charge upon the ratepayers of such district.

Designation
of seats of
councillors.

5. For the first general election held after the date of the coming into force of this act, the seats of the three councillors to be elected shall be designated by the numbers 1, 2 and 3, and, for the ensuing general election, the seats of the other three councillors to be elected shall be designated by the numbers 4, 5 and 6.

After the holding of the first and second general elections, the seats of the councillors shall continue to be designated as above.

Real estate
qualification
for coun-
cillors.

6. During twenty years from the coming into force of this act the persons eligible for nomination to seats numbers 3 and 6 must possess their real estate qualification within the limits of District No. 2.

Responsi-
bility for
debts con-
tracted.

7. The debts contracted by the former municipality of Jeanne-d'Arc before the 19th of February, 1932, and the claims resulting from the acts imputable to the said former municipality of Jeanne-d'Arc and carried out prior to such date shall be a charge only upon the ratepayers of the above-

mentioned District No. 2, and the debts contracted by the municipality of Sainte-Monique before the 19th of February, 1932, and the claims resulting from the acts imputable to the municipality of Sainte-Monique and carried out prior to such date shall be a charge only upon the ratepayers of the above-mentioned District No. 1.

8. In all other respects, the provisions of the Municipal Provisions Code which are not inconsistent with those of this act ^{Provisions} applicable, shall apply to the municipality of Sainte-Monique from ^{after an-} the date of the annexation hereinabove enacted. ^{nexation.}

9. This act shall come into force on the day of its ^{Coming into} sanction. ^{force.}
