



# 21 GEORGE V

## CHAPTER A

An Act granting to His Majesty the moneys urgently required for defraying the charges and expenses of the Government and public service of the Province during the current session of the Legislature

*[Assented to, the 4th of April, 1931]*

MOST GRACIOUS SOVEREIGN,

**W**HEREAS it appears, by message from The Honourable Preamble.  
Henry George Carroll, LL.D., K.C., Lieutenant-Governor of this Province, and the estimates accompanying the same, that the sums hereinafter mentioned are required for defraying the charges and expenses of the Government and public service of the Province during the current session of the Legislature; May it therefore please Your Majesty that it may be enacted, and be it enacted, by the King's Most Excellent Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, that:

**1.** From and out of the consolidated revenue fund of this Province, there shall and may be taken a sum, not exceeding, in the whole, four hundred and twenty thousand, eight hundred and thirty-eight dollars and twenty-five cents, for defraying the charges and expenses of the Government and public service of the Province during the current session of the Legislature, as set forth in the Schedule annexed to this act. Amount that may be taken for charges, etc., during session of 1930-31.

**2.** Every payment or application of moneys, appropriated by this act, shall be held to be made provisionally, and subject to all adjustment in account hereinafter, in respect of the Dominion and of the Province of Ontario, and of special funds which this act may in any manner affect.

**3.** Accounts, in detail, of all moneys expended under the authority of this act shall be laid before both Houses of the Legislature of the Province, in conformity with section 22 of the Provincial Audit Act (Revised Statutes, 1925, chapter 21).

**4.** The application of all sums expended under the authority of this act shall also be accounted for to His Majesty.

**5.** This act shall come into force on the day of its sanction.
