



CHAPTER 16

An Act to detach certain lots from the electoral district of Bellechasse and to annex them to the electoral district of Dorchester, for all purposes

[Assented to, the 4th of April, 1931]

HIS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. The lots of the tenth, eleventh and twelfth ranges of the official plan and book of reference of the cadastre for the township of Ware are detached from the electoral district of Bellechasse and annexed to the electoral district of Dorchester, for all purposes including school purposes, and as to such school purposes, from the next school year, and are declared to have formed part in the past, for school purposes, of the parish municipality of Ste. Sabine, county of Bellechasse; they are declared to form part of the parish municipality of St. Luc, county of Dorchester.

2. Section 7 of the Territorial Division Act (Revised Statutes, 1925, chapter 2) is amended:

a. By replacing the words: "all the lots of the tenth, eleventh, twelfth, thirteenth and fourteenth ranges of the township of Ware", in the twenty-ninth, thirtieth, thirty-first and thirty-second lines of the second paragraph of paragraph No. 7 of the Table of the Electoral Districts contained in the said section 7, by the words: "all the lots of the thirteenth and fourteenth ranges of the township of Ware";

b. By replacing the words: "less the lots of the tenth, eleventh, twelfth, thirteenth and fourteenth ranges of the said township, which also form part of the parish municipi-

pality of Ste. Sabine and belong to the electoral district of Bellechasse (O.G. 1908, p. 1500; 8 Ed. VII, c. 14)", in the fifteenth, sixteenth, seventeenth, eighteenth, nineteenth, twentieth, twenty-first and twenty-second lines of the second paragraph of paragraph No. 18 of the Table of the Electoral Districts contained in the said section 7, by the words: "less the lots of the thirteenth and fourteenth ranges of the said township, which also form part of the parish of Ste. Sabine and belong to the electoral district of Bellechasse".

Certain lots declared to form part of Ste. Sabine. **3.** The lots of the thirteenth and fourteenth ranges of the municipality are declared to have always formed part, notwithstanding the act 8 Edward VII, chapter 14, of the parish municipality of Ste. Sabine, county of Bellechasse, for school purposes.

Idem. **4.** The lots of the tenth, eleventh and twelfth ranges, above mentioned, are declared to have formed part, for school purposes, of the parish municipality of Ste. Sabine, county of Bellechasse, and shall remain attached to the said municipality up to the next school year.

Coming into force. **5.** This act shall come into force on the day of its sanction.
