



CHAPTER 64

An Act to amend the act 13 George V, chapter 44

[Assented to, the 4th of April, 1931]

HIS MAJESTY, with the advice and consent of the
Legislative Council and of the Legislative Assembly
of Quebec, enacts as follows:

1. Sections 1 and 2 of the act 13 George V, chapter 44, 13 Geo. V, c. 44, ss. 1, 2, replaced.
are replaced by the following:

"1. Except as provided in section 7 of the act 21 George V, chapter 63, and in sub-paragraph *a* of section 11 thereof, Payment of taxes by non-Catholic, non-Protestant property-owners, into the Neutral Panel.
in the territory under the jurisdiction of the Montreal Protestant Central School Board, all non-Roman Catholic, Protestant non-Protestant property-owners shall pay their school taxes into the Neutral Panel at the rate fixed for the Protestants.

"2. In the said territory, all non-Roman Catholic, non-Protestant children attending the schools of the Roman Catholic or of the Protestant system shall be subject to the payment of the same fees, if any, as may be required of Roman Catholic or Protestant pupils, as the case may be." Payment of fees.

2. Section 3 of the act 13 George V, chapter 44, temporarily repealed by the act 19 George V, chapter 48, sections 1 and 3, and replaced by the act 20 George V, chapter 61, section 19, is again replaced by the following: 13 Geo. V, c. 44, s. 3, replaced.

"3. In the said territory, the cost of educating non-Roman Catholic, non-Protestant pupils, in either system, shall be paid out of the funds of the Neutral Panel to the board educating them, as a charge thereon, and shall be reckoned at the *per capita* cost, calculated on the basis of the total enrollment up to the thirtieth of April of the preceding school year." Per capita cost.

13 Geo. V, c. 44, s. 4, replaced. **3.** Section 4 of the act 13 George V, chapter 44, temporarily repealed by the act 19 George V, chapter 48, sections 1 and 3, and replaced by the act 20 George V, chapter 61, section 20, is again replaced by the following:

Annual report. **"4.** In the said territory, each of the school boards must send to the treasurer of the municipal corporation concerned, on or before the 15th of September of each year, a report, duly certified by the chairman and the secretary-treasurer of the board, and approved by resolution of that board, showing the total enrollment of non-Roman Catholic, non-Protestant children up to the thirtieth of April of the preceding school year, and, except in the city of Montreal, a statement, certified by the auditor of the board, showing the total expenditure, exclusive of capital expenditure, made by the board during the preceding school year. The division of the total expenditure of the board by the total enrollment of all pupils in its schools will establish the *per capita* cost.

Id., in Très St-Sacrement. Nevertheless, in the territory of the municipality of Très Saint-Sacrement, in the county of Jacques Cartier, the *per capita* cost shall be calculated on the basis of the total enrollment of such pupils in the schools in such territory up to the thirtieth of April of the preceding year."

13 Geo. V, c. 44, ss. 4a, 4b, added. **4.** The said act is amended by adding thereto, after section 4 thereof, the following sections:

Cost of educating certain children in Montreal. **"4a.** Notwithstanding the provisions of the sections 3 and 4 of this act, in the city of Montreal, the cost of educating the non-Roman Catholic, non-Protestant children and the children professing the Jewish faith shall be determined under the provisions of section 10 of the act 21 George V, chapter 63, and the apportioning of the Neutral Panel tax shall be made in conformity with the provisions of the said section 10 of the said act.

Id., in Outremont. **"4b.** Notwithstanding the provisions of sections 3 and 4 of this act, in the city of Outremont, the cost of educating non-Roman Catholic, non-Protestant children professing the Jewish faith shall be determined under the provisions of section 11 of the act 21 George V, chapter 63."

13 Geo. V, c. 44, s. 7, replaced. **5.** Section 7 of the act 13 George V, chapter 44, as replaced by the act 20 George V, chapter 61, section 22, is again replaced by the following:

Indications on valuation roll. **"7.** In the said territory, subject to the provisions of section 7 and of sub-paragraph *e* of section 11 of the act

21 George V, chapter 63, concerning the city of Montreal and the city of Outremont, the assessors of each municipal corporation shall indicate upon the valuation roll all non-Roman Catholic, non-Protestant property-owners paying school taxes, by putting the letter "N" opposite the entries of such property-owners."

6. Part X of chapter 133 of the Revised Statutes, 1925, shall not apply to the territory under the jurisdiction of the Montreal Protestant Central School Board. Provisions not applicable to certain territory.

7. This act shall come into force on the day of its sanction. Coming into force.
