



## CHAPTER 160

An Act respecting the closing of a portion of the lane behind certain lots on St. Joseph Boulevard, and forming part of lot No. 329, subdivision 286, of the official plan and book of reference of the village of Côte St. Louis

[Assented to, the 4th of April, 1931]

**W**HEREAS *L'Institut de Notre-Dame-du-Bon-Conseil de* Preamble.

*Montréal*, a body corporate incorporated by the act 15 George V, chapter 134, has, by its petition, represented that it is owner of the lots numbers three hundred and sixteen, three hundred and seventeen, three hundred and eighteen and three hundred and nineteen of the official subdivision of lot number three hundred and twenty-nine (329—316, 317, 318 and 319) of the official plan and book of reference of the village of Côte St. Louis, fronting on DeLaroche street, and that it is also owner of the lots numbers three hundred and forty-two, three hundred and forty-three and three hundred and forty-four of the official subdivision of the said lot number three hundred and twenty-nine (329—342, 343 and 344) of the same cadastre, the latter lots fronting on St. Joseph Boulevard; that the lots situated on DeLaroche street are separated from those situated on St. Joseph Boulevard by a lane which forms part of lot number two hundred and eighty-six of the official subdivision of the said lot number three hundred and twenty-nine (329—286) of the said cadastre; that the Institute's normal development is hindered by the existence of such lane; that the closing of the lane next to the DeLaroche street lot would occasion no inconvenience as the neighbouring proprietors have two nearby outlets; that the churchwardens of the parish of St. Stanislas have adopted a motion asking for the closing of the lane in question, as well as the members of the St. Jean-Baptiste So-

city of Montreal, and the council of the city of Montreal has declared itself in favour of the closing of the said lane and the gratuitous transfer to *L'Institut de Notre-Dame-du-Bon-Conseil de Montréal*, of the land comprised in the said lane;

And whereas it is expedient to grant the prayer contained in the said petition;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

**1.** The city of Montreal is authorized to close the portion of the lane situated in rear of the lots on St. Joseph Boulevard forming part of lot number three hundred and twenty-nine, subdivision two hundred and eighty-six (329—286), of the official plan and book of reference of the village of Côte St. Louis, starting from DeLaroche street, on the entire depth of subdivision number three hundred and nineteen of lot number three hundred and twenty-nine (329—319) of the official plan and book of reference of the village of Côte St. Louis, and to cede the said lot gratuitously to *L'Institut de Notre-Dame-du-Bon-Conseil de Montréal*.

**2.** This act shall come into force on the day of its sanction.
