



## CHAPTER 188

An Act to authorize the College of Dental Surgeons of the Province of Quebec to admit Luther Hamilton Stilwell to the practice of dental surgery

*[Assented to, the 11th of March, 1931]*

**W**HEREAS Luther Hamilton Stilwell, of the city and Preamble.  
district of Montreal, dental surgeon, has by his petition represented that in the month of June, 1915, he passed the matriculation examinations required for admission as a student in the Faculty of Arts at McGill University, Montreal, which examination likewise qualified him to pass the examination for admission to the study of dental surgery or medicine at the same university;

That he was duly registered and attended regularly the sessions and lectures of the first year of arts of the said university during the session 1915-1916, and in May, 1916, voluntarily enlisted in the Canadian Expeditionary Forces and was in active service until he returned to Canada in October, 1918;

That on returning to Montreal he registered as a medical student at McGill University, being qualified so to do, and continued his studies in that faculty until April, 1920;

That in the month of October, 1920, he transferred from the medical course to the dental course at McGill University without, however, having passed the necessary examination for admission to the study of dentistry as required by law;

That owing to the circumstances enumerated hereabove he was unable to prepare for the examination for admission to the study of dentistry;

That subsequently in the month of May, 1929, after his course had been interrupted by circumstances over which he had no control, he obtained a diploma of Doctor

of Dental Surgery from McGill University, after having successfully followed the four years' course in the said University and having graduated therefrom with honors;

That since the month of June, 1929, he has been attached to the staff of the Royal Victoria Hospital, Dental Surgery Department, in which department he is at present engaged;

That by his studies and experience he has acquired the necessary knowledge to be admitted to the practice of dental surgery and to the exercise of the said profession;

That the Board of Governors of the College of Dental Surgeons of the Province of Quebec on the twenty-second day of March, 1930, consented to the passing of an act to authorize the College of Dental Surgeons of the Province of Quebec to permit him to practise his profession of dental surgery in the Province of Quebec, after undergoing an examination for admission to practice, but without examination for the admission to study;

Whereas he has prayed for the passing of an act to that effect and it is expedient to grant his prayer;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of the Province of Quebec, enacts as follows:

**1.** The College of Dental Surgeons of the Province of Quebec is authorized to admit the said Luther Hamilton Stilwell among its members and to grant him the license required for the Province of Quebec to permit him to practise the profession of dentist in this Province, after examination for admission to practice, but without examination for admission to study.
