



## CHAPTER 2

An Act to provide for the construction of a bridge over the  
Des Prairies river

[Assented to, the 4th of April, 1930]

**HIS MAJESTY**, with the advice and consent of the  
Legislative Council and of the Legislative Assembly  
of Quebec, enacts as follows:

**1.** The Lieutenant-Governor in Council may authorize the Minister of Public Works and Labour to have a bridge built over the Des Prairies river, to connect the municipality of the parish of St. Raphaël de l'Ile Bizard with the municipality of the town of Laval-sur-le-Lac, at or near their boundaries, at the most suitable place for the Ste. Geneviève-St. Eustache highway, with all the necessary approaches and works, the whole at a cost of not more than three hundred thousand dollars.

**2.** The Lieutenant-Governor in Council is authorized to acquire, by agreement or by expropriation, all immoveables, immoveable rights, charges, leases for occupation, emphyteutic leases, constituted rents or any other rights whatsoever for the approaches, abutments, piers or other works necessary. Any expropriation required for the purposes of this act shall be subject to the provisions of the Quebec Railway Act, *mutatis mutandis*.

**3.** To pay for the construction of the bridge and the necessary works as well as the acquisitions authorized under sections 1 and 2 of this act, the Provincial Treasurer may pay, out of the consolidated revenue fund, upon certificates of the Minister of Public Works and Labour, the sums required for the carrying out of this act.

Loans authorized by means of debentures, etc.

**4.** The Lieutenant-Governor in Council may, if he deem it expedient, authorize the Provincial Treasurer to contract, from time to time, by means of debentures or inscribed stock, issued on the credit of the Province, such loan or loans as he thinks necessary for the purposes of this act, but the loan or loans so contracted shall not exceed the sum of three hundred thousand dollars.

Interest on debentures, etc.

Such debentures or inscribed stock shall bear interest at a rate of not more than six per cent per annum, and shall be for such term, in such form and for such amount as the Lieutenant-Governor in Council may determine, and shall be payable, in principal and interest, annually or semi-annually, at the place indicated by him.

Advances.

**5.** The Lieutenant-Governor in Council, pending the negotiation of the said loan or loans, may also authorize the Provincial Treasurer to advance, from time to time, out of the consolidated revenue fund, the sums necessary to carry out this act.

Tolls.

**6.** Tolls may be charged and collected on the said bridge, up to the amount expended for the acquisitions mentioned in section 2, as well as for the cost of construction of the said bridge; and the Lieutenant-Governor in Council may make, amend and replace a tariff of tolls payable.

Coming into force.

**7.** This act shall come into force on the day of its sanction.
