



CHAPTER 7

An Act respecting agricultural schools and the construction of warehouses and concerning the *Société Coopérative Fédérée des Agriculteurs de la Province de Québec*

[Assented to, the 4th of April, 1930]

WHEREAS it is expedient to establish, enlarge, Preamble.
furnish and equip agricultural schools in the
Province of Quebec;

Whereas it is expedient to construct warehouses for the
storing of agricultural products;

Whereas it is expedient to make a loan to the *Société
Coopérative Fédérée des Agriculteurs de la Province de Québec*,
or to guarantee a loan of the said society;

Therefore, His Majesty, with the advice and consent of
the Legislative Council and of the Legislative Assembly of
Quebec, enacts as follows:

1. A sum of six hundred thousand dollars is appro- Appropriation for agri-

In order to procure the land required for such con- Acquisitions
struction, in whole or in part, the Lieutenant-Governor in authorized.
Council is authorized to acquire, by agreement or expro-

priation, the necessary immoveable properties and every immoveable right, charge, lease for occupation or emphyteutic lease, constituted rent, or other rights affecting such immoveable properties.

Provisions applicable. Every expropriation necessitated for the purposes of this act shall be governed by the Quebec Railway Act, *mutatis mutandis*.

Advance out of consol. rev. fund. The Provincial Treasurer may, from time to time, advance and pay out of the consolidated revenue fund, to the extent of the said sum of five hundred thousand dollars, upon certificates of the Minister of Agriculture, the amounts required to pay the price of the immoveable properties and immoveable rights, above mentioned, and to defray, in whole or in part, the cost of construction; or, the Lieutenant-Governor in Council is authorized, for the purposes of making such acquisitions and to provide for the cost of construction, to contract a loan or loans, not to exceed in the aggregate the sum of five hundred thousand dollars, by means of debentures or inscribed stock, issued on the credit of the Province.

Loans authorized. Such debentures or inscribed stock shall bear interest at a rate of not more than six per cent per annum, and shall be for such term, in such form and for such amount as the Lieutenant-Governor in Council shall determine, and shall be payable, in principal and interest, annually or semi-annually, at such place or places as he may indicate.

Interest, etc.

Certain loan or guarantee, authorized. **3.** The Minister of Agriculture is authorized to make a loan not exceeding seven hundred and fifty thousand dollars to the *Société Coopérative Fédérée des Agriculteurs de la Province de Québec*, or to guarantee a loan or loans, not exceeding in the aggregate seven hundred and fifty thousand dollars, that may be contracted by the said society, the said amount to be paid to the Minister of Agriculture, if need be, by the Provincial Treasurer out of the consolidated revenue fund, on an order of the Lieutenant-Governor in Council.

Coming into force. **4.** This act shall come into force on the day of its sanction.
