



CHAPTER 31

An Act to amend the Motor Vehicle Act

[Assented to, the 4th of April, 1930]

HIS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. Section 2 of the Motor Vehicle Act (Revised Statutes, 1925, chapter 35), as amended by the acts 16 George V, chapter 19, section 1, and 17 George V, chapter 20, section 1, is again amended by striking out subsection 18 thereof.

2. The said act is amended by adding thereto, after section 3 thereof, the following section:

“3a. No registration of a motor vehicle acquired and possessed by a person under twenty-one years of age, unless such person is a trader, shall be applied for and effected unless the written consent of the father, mother or tutor, as the case may be, of such person, to such registration, be filed in the Bureau.

Such consent shall render the person giving the same jointly and severally responsible for the fine imposed upon the licensee for any infraction of this act, as well as for any loss or damage sustained by anyone through the use of the said motor vehicle.”

3. Section 11 of the said act, as replaced by the act 16 George V, chapter 19, section 3, is amended by adding thereto the following subsection:

“4. When the transfer occurs through the cancellation of a conditional sale, and the purchaser thereunder or neglects to sign the notice or to deliver to those having

a right thereto the certificate of registration or the registration markers issued therefor for the then current registration year, the Bureau, upon satisfactory proof of such refusal or neglect and that the vendor thereunder has repossessed the motor vehicle, may cancel the registration of the motor vehicle without reimbursement, and register the same in the name of the said vendor for the balance of the registration year, upon payment of a fee of two dollars."

4. Section 24 of the said act is amended by striking out the words: "and, in the case of a chauffeur, that the badge be also returned", in the fourth and fifth lines thereof.

5. The title of Division IV of the said act is amended by striking therefrom the words: "and badges".

6. Section 25 of the said act is amended:

a. By striking out the words: "If such person be a chauffeur, he must also carry the badge issued to him by the Bureau, for the current year.", in the fourth and fifth lines of subsection 1 thereof;

b. By striking out the words: "or, in the case of a chauffeur, such badge", in the second line of subsection 2 thereof.

7. Section 49 of the said act is amended:

a. By adding thereto, after the word: "name", in the first line of subsection 2 thereof, the words: "fictitious age";

b. By striking out subsection 6 thereof.
