



## CHAPTER 43

### An Act to amend the Game Laws

[Assented to, the 4th of April, 1930]

**HIS MAJESTY**, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

**1.** Section 4 of the Game Laws (Revised Statutes, 1925, R. S. c. 86, chapter 86), as amended by the acts 18 George V, chapter 33, section 2, and 19 George V, chapter 29, section 1, is again amended by replacing paragraph 3 thereof by the following:

“3. to hunt, kill or take caribou, at any time of the Caribou. year up to the first of January, 1935;”

**2.** Section 5 of the said act is amended:

*a.* By replacing the words: “two deer and two caribou”, in the second and third lines of the first paragraph of subsection 1 thereof, by the words: “and two deer”;

*b.* By replacing the words: “more than two deer, or more than two caribou”, in the second and third lines of the second paragraph of said subsection 1 thereof, by the words: “or more than two deer”;

*c.* By striking out the words: “three additional caribou and”, in the fourth and fifth lines of the third paragraph of said subsection 1.

**3.** Section 6 of the said act, as amended by the act 17 Id., s. 6, am. George V, chapter 30, section 1, is again amended:

*a.* By replacing sub-paragraph *a* of subsection 1 thereof by the following:

- Otter. "a. any otter, between the first day of April of any year and the fifteenth day of December of the same year; any
- Beaver. beaver at any time of the year, up to the first of January, 1935;"
- Beaver. b. By replacing the second paragraph of subsection 2 thereof by the following:
- Beaver. "for beaver, not less than twenty-five dollars nor more than fifty dollars, per head";
- Permit to Indians. c. By adding thereto, after the second paragraph of subsection 4 thereof, the following paragraph:
- Permit to Indians. "The Lieutenant-Governor in Council may, notwithstanding the above prohibition, permit Indians, subject to the conditions he determines, to hunt beaver in certain parts of the Province indicated by him."
- R. S., c. 86, s. 10, am. **4.** Section 10 of the said act is amended by replacing the figures: "1930", in the third line of the first paragraph of subsection 1 thereof, by the figures: "1935".
- Id., s. 24, am. **5.** Section 24 of the said act, as amended by the act 19 George V, chapter 29, section 2, is again amended by adding thereto, after the word: "whatsoever", in the sixth line of the third paragraph thereof, the words: "or any fire-ranger in the performance of his duties,".
- Id., s. 47, replaced. **6.** Section 47 of the said act is replaced by the following:
- Bounty for killing wolves. "47. The Minister may pay, out of the revenues derived from the carrying out of this act, a bounty to any inhabitant of the Province, who proves to him in the manner hereinafter determined that he has killed one or more wolves within the Province. The amount of the bounty for each wolf destroyed shall be fixed by the Lieutenant-Governor in Council. The entire pelt, including the scalp, shall be cleaned and sent to the Department, at the shipper's expense, with a declaration in the form prescribed, sworn to before a justice of the peace, establishing the place where and the date on which he killed such wolf or wolves. The pelt, after having been marked in the manner ordered by the Minister, shall be returned to the shipper at the Department's expense."
- Coming into force. **7.** This act shall come into force on the day of its sanction.
