



CHAPTER 114

An Act to amend the charter of the town of St. Laurent

[Assented to, the 20th of March, 1930]

WHEREAS the town of St. Laurent has, by its petition, Preamble.
represented that its charter, the act 8 Edward VII,
chapter 94, as amended by the acts 3 George V, chapter
71; 8 George V, chapter 91, and 13 George V, chapter 97, no
longer meets the requirements of the said municipality and
that it needs, for the proper administration of its territory,
additional powers;

Whereas by the act 3 George V, chapter 71, when the
town of St. Laurent annexed certain territories, it was
enacted that lands under cultivation or farmed could not
be valued at a higher sum than two hundred dollars per
arpent, for a period of fifteen years which has now termi-
nated;

Whereas at the time of the passing of that act, it was ex-
pected that these lands would, in such space of time, be
converted into town lots and built upon;

Whereas most of the lands in question have remained
in a state of cultivation, their owners being unable to derive
other revenue therefrom or to dispose of them otherwise;

Whereas the owners of land under cultivation or farmed
in the limits of the town of St. Laurent are asking the latter
not to be valued at more than three hundred dollars per
arpent for a period of ten years from the 1st of January,
1930;

Whereas the aforesaid owners undertake to defray, jointly
and severally, in proportion to the number of arpents which
they own, all expenditure which the said town of St. Lau-
rent shall make to obtain a special act from the Legislature
authorizing the town of St. Laurent to value the said lands
at a sum not to exceed three hundred dollars per arpent, for
a period of ten years from the 1st of January, 1930;

Whereas, under the circumstances, it would be just that the valuation of such properties do not exceed the sum of three hundred dollars, as long as they continue to be operated as at present;

Whereas certain lots were sold by the petitioner for non-payment of the municipal and school taxes for more than three years;

Whereas it is expedient to ratify, validate and confirm such sales of lands made by the said town of St. Laurent for non-payment of taxes, in order to remove all doubt which may arise respecting the validity of these sales;

Whereas the said town of St. Laurent has prayed for the passing of an act for the above purposes and whereas it is expedient to grant such prayer;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

3 Geo. V, c. 71, s. 2, replaced. **1.** Section 2 of the act 3 George V, chapter 71, is replaced by the following:

R. S., c. 102, s. 522, replaced, for the town. **"2.** Section 522 of the Cities and Towns' Act (Revised Statutes, 1925, chapter 102) is replaced, for the town, by the following:

Taxation of farming lands. **"522.** No land under cultivation or farmed or used as pasture for cattle, and no uncleared land or wood lots within the municipality shall be taxed to an amount exceeding one-fourth of the general and regular rate of the tax upon the other immoveables of the municipality. Nevertheless the said land under cultivation or farmed shall not be valued at a higher amount than three hundred dollars per acre for a period of ten years from the first of January, 1930.

Additions to roll in certain cases. The council may cause to be added to the valuation roll, at any time, by the assessors in office on the valuation by them made, any portion of such land, which has been detached therefrom as a building lot, and shall thus have become liable to taxation after the closing of the valuation roll, and may exact the said tax as upon all other lots entered on the said roll."

Expenses of passing of act. **2.** The owners concerned shall be obliged to defray, in proportion to the number of arpents whereof they are owners, all expenses incurred by the said town of St. Laurent, to obtain, from the Legislature, the passing of this act, within thirty days of its sanction.

Sales validated as to certain taxes. **3.** The sales of certain lots in the town of St. Laurent, effected by the said town for non-payment of municipal and

school taxes, on the 6th of June, 1927; 21st, 22nd and 23rd of August, 1928; 18th of September, 1928; 20th of November, 1928; 15th of April, 1929; 6th of May, 1929, and 3rd of July, 1929, enumerated in the lists reproduced as schedule A to this act, for the sales of the 6th of June, 1927; as schedule B, for the sales of the 21st, 22nd and 23rd of August, 1928; as schedule C, for the sales of the 18th of September, 1928; as schedule D, for the sales of the 20th of November, 1928; as schedule E, for the sales of the 15th of April, 1929; as schedule F, for the sales of the 6th of May, 1929, and as schedule G, for the sales of the 3rd of July, 1929, are hereby declared valid only as regards the period of taxes claimed, but those concerned who have not renounced the prescription and who avail themselves of the right of redemption shall not be obliged to pay the taxes for a period beyond the last three years.

4. This act shall come into force on the day of its sanc-
tion. Coming into
