



CHAPTER 122

An Act to ratify certain contracts concerning the city of Montreal

[Assented to, the 20th of March, 1930]

HIS MAJESTY, with the advice and consent of the
Legislative Council and of the Legislative Assembly
of Quebec, enacts as follows:

e. Deed of sale by the city of Montreal to Nicholas
Greco *et al.*, entered into before Jean Baudouin, N. P., on

f. Deed of sale by the city of Montreal to Dame Natha-
lie Barbeau, widow of François Xavier Tessier, entered

g. Deed of retrocession by the city of Montreal to Montreal City Land Company, Limited, entered into before Jean Baudouin, N. P., on the 20th of November, 1929, under number 11855 of the minutes of his repertory;

h. Deed of sale by the city of Montreal to Dominion Oilcloth and Linoleum Company, Limited, entered into before Jean Baudouin, N. P., on the 27th of November, 1929, under number 11863 of the minutes of his repertory;

i. Deed of exchange between the city of Montreal and The Shawinigan Water and Power Company entered into before Jean Baudouin, N. P., on the 24th of December, 1929, under number 11895 of the minutes of his repertory;

j. Deed of exchange between the city of Montreal and the Montreal Harbour Commissioners, entered into before Jean Baudouin, N. P., on the 7th of January, 1930, under number 11906 of the minutes of his repertory;

k. Deed of exchange between the city of Montreal and the Montreal Harbour Commissioners, entered into before Jean Baudouin, N. P., on the 7th of January, 1930, under number 11907 of the minutes of his repertory;

l. Deed of sale by the city of Montreal to Dame Mary Henry, widow of Arthur Boisvert, entered into before Jean Baudouin, N. P., on the 6th of February, 1930, under number 11945 of the minutes of his repertory;

m. Resolution of the council of the city of Montreal, dated the 4th of November, 1929, approving an arrangement between the city of Montreal and Viewmont Land Company respecting the transfer of certain streets, and also the deed to be executed in conformity with such resolution;

Coming into force. **2.** This act shall come into force on the day of its sanction.
