



CHAPTER 126

An Act respecting the maintenance of certain roads in the
county of Laval

[Assented to, the 20th of March, 1930]

WHEREAS the municipality of the county of Laval Preamble.
has by its petition represented:

That its territory is crossed by three regional highways whose maintenance is under the control of the council of the county of Laval as to part, under the act 2 George V, chapter 3, as amended by the act 8 George V, chapter 8, and of the councils of the local municipalities which they cross, as to the balance;

That, by section 17 of chapter 2 of the Revised Statutes of Quebec, 1925, the town of Laval-des-Rapides and the town of Laval-sur-le-Lac, situated on Ile Jésus, do not form part of the county of Laval for municipal purposes;

That notwithstanding these provisions, the town of Laval-des-Rapides is obliged to contribute to certain roads under the provisions of the act 2 George V, chapter 3;

That, for the proper administration of the county of Laval and to secure uniform maintenance of the principal highways crossing Ile Jésus, during winter time, it is necessary to place the upkeep of these roads under the control of the council of the county of Laval and to have all the municipalities of the county contribute to such upkeep, as well as the towns of Laval-des-Rapides and Laval-sur-le-Lac;

That the town municipalities situated on Ile Jésus have agreed to the passing of this act;

Whereas it is expedient to grant the prayer to that effect contained in the said petition;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

Roads under jurisdiction of county of Laval.

1. The following roads crossing Ile Jésus shall, during winter time, be county roads, from the 1st of December, 1929, under the exclusive jurisdiction of the county of Laval, namely:

a. The road from Viau bridge, along river des Prairies, in the parish of St. Vincent de Paul, crossing the village of St. Vincent de Paul as far as Masson hill, and the said Masson hill to the Terrebonne bridge over river Jésus, in the parish of St. François-de-Sales;

b. The road from the said Viau bridge, along river des Prairies, partly situated in the municipality of Pont Viau, partly in the town of Laval-des-Rapides and the remainder in the village of l'Abord à Plouffe, extending to the "Montée St. Martin", that is to Elzéar Lagacé's hotel, thence in a northerly direction to the village of St. Martin, to the grand range of St. Martin, thence westerly, passing in front of the church of St. Martin, extending as far as Ste. Dorothée, crossing this village by following the Montreal-Hull regional highway as far as Bellefeuille bridge in the parish of Ste. Rose;

c. The road from Viau bridge known under the name of "Montée Ste. Rose", extending as far as the Ouimets' hill and thence westerly to Belair bridge in the town of Ste. Rose, and thus crossing part of the parish of Ste. Rose and part of the town of Ste. Rose.

Maintenance of roads during winter.

2. The said roads shall be maintained during winter time, under the control of the council of the county of Laval, by the said county and the towns of Laval-des-Rapides and Laval-sur-le-Lac, according to their respective valuations.

Payment of debts.

3. Each municipality of the Ile Jésus shall continue, however, to pay the debts contracted by each of them respectively for the making or repairing of the said roads.

Coming into force.

4. This act shall come into force on the day of its sanction.
