



CHAPTER 160

An Act respecting the trustees for the parish of Ste. Thérèse d'Amos

[Assented to, the 4th of April, 1930]

WHEREAS the trustees for the parish of Ste. Thérèse Preamble.
d'Amos have, by their petition, represented:

That in 1922, they assessed Catholic owners of immovable property to pay for the erection of a church;

That on the 7th of July, 1928, they made a new act of assessment instead of revising that of 1922 and in view of the proposed erection of two new parishes, whose territory would include some immoveables affected by the said assessment, the trustees omitted the said immoveables from the new act, so that their owners should not have to contribute to the expense of two churches at the same time;

That the immoveables so omitted from the said act are the following:

“Lots 55 to 62 inclusively of ranges 1, 2 and 3 of the township of Dalquier;

“All the portion of range 4 of the said township situated to the east of river Harricana;

“Ranges 5, 6, 7, 8, 9 and 10 of the said township”;

That the new act of 1928, so made, was homologated by the civil commissioners on the 5th of September, 1928, and submitted for the approval of the Lieutenant-Governor in Council but after the delay provided by law;

That one of the new parishes mentioned above has since been canonically erected and the boundaries of the other are now fixed;

That a third parish will probably be erected, comprising lots 1 to 16 inclusively of ranges 2, 3 and 4 of the said township;

That it is in the public interest that the said act of assessment and any revision or any new act replacing it shall take into account the above-mentioned dismemberments;

That it is necessary to authorize the trustees to exact payment of the said assessment in order that they may be in a position to pay, at their maturity, the loans contracted by them;

Whereas the petitioners have prayed for the passing of an act for the above purposes, and

Whereas it is expedient to grant such prayer;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

Homologation of act of assessment validated.

1. The omission by the trustees for the parish of Ste. Thérèse d'Amos of any mention in the act of assessment made by them on the 7th of July, 1928, of the following immoveables namely: "lots 55 to 62 inclusively of ranges 1, 2 and 3 of the township of Dalquier; all the portion of range 4 of the said township situated to the east of river Harricana; and ranges 5, 6, 7, 8, 9 and 10 of the said township", shall not have the effect of invalidating the said act of assessment, and the homologation of the said act by the commissioners for the civil erection of parishes in the diocese of Haileybury, dated the 7th of July, 1928, established by an extract from the minute book of the deliberations of the said commissioners, is validated and shall take the place of any approval required by the provisions of the Parish and *Fabrique* Act (Revised Statutes, 1925, chapter 197).

Power to exact payment of instalments.

2. The trustees are empowered to exact payment, in accordance with the said act of assessment of 1928, of the instalments of the said assessment due in 1928 and in 1929, as well as the instalments to become due.

Payments validated.

3. All payments made to the trustees under the said act are declared valid.

Omission authorized.

4. The trustees are authorized to omit from any revision of such assessment and from any new act replacing same the immoveables described in section 1 of this act.

Idem.

5. The trustees are also authorized to omit, from any revision of the said act of assessment and from any new act replacing same, the lots 1 to 16 inclusively of ranges 2, 3 and 4 of the township of Dalquier, whenever such immoveables become part of a new civil or canonical parish.

Coming into force.

6. This act shall come into force on the day of its sanction.
