



CHAPTER 178

An Act to ratify certain by-law and resolutions relating to the valuation and assessment of the properties of the E. B. Eddy Company, Limited

[Assented to, the 4th of April, 1930]

WHEREAS the E. B. Eddy Company, Limited, has, by Preamble. its petition, represented that on the 3rd day of February, 1930, a by-law bearing No. 280 was passed by the council of the city of Hull and was thereafter approved unanimously by the elector-proprietors, which by-law granted unto the said E. B. Eddy Company, Limited, its successors and assigns, a fixed valuation of four million dollars for municipal purposes, for a period of ten years, on the immoveable properties, buildings, improvements, presently or which may be hereafter erected on any of the lands of the said company for the purposes of its industry;

That the school commissioners of the city of Hull at a meeting held on the 18th of January, 1930, approved said by-law insofar as they were concerned, subject to the said valuation being increased for school purposes to four million six hundred and fifty-seven thousand one hundred and twenty-nine dollars, for a period not to exceed ten years from the 1st of May, 1930;

That the trustees of the dissentient minority of the municipality of the city of Hull, at a meeting held on the 5th day of February, 1930, adopted a resolution fixing the valuation of petitioner's properties at a sum of four million six hundred and fifty-seven thousand one hundred and twenty-nine dollars for school purposes, for a period of ten years to be computed from the ratification of said resolution by the Legislature of the Province of Quebec;

That these concessions were made to the E. B. Eddy Company, Limited, in view of the establishment by it in

the said municipality of an industry which is of great benefit and which gives employment to a great many people and in view of the fact that the company intends to enlarge its manufacture and to construct new ones which will give employment to a greater number of persons in the city of Hull;

That it is expedient that the aforesaid by-law and resolutions be ratified and confirmed;

Whereas it is expedient to grant the prayer of said petition;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

By-law No.
280, ratified.

1. By-law No. 280 of the council of the city of Hull, granting to the E. B. Eddy Company, Limited, its successors and assigns, a fixed municipal valuation of four million dollars for a period of ten years, is hereby ratified and confirmed and declared valid and obligatory.

2. The resolution of the board of school commissioners of the city of Hull, under date of January 18th, 1930, fixing at four million six hundred and fifty-seven thousand one hundred and twenty-nine dollars the valuation and assessment of the properties of the said company for school purposes, is hereby ratified and confirmed and declared valid and obligatory.

3. The resolution of the trustees of the dissentient minority of the municipality of the city of Hull, under date of February 5th, 1930, fixing at four million six hundred and fifty-seven thousand one hundred and twenty-nine dollars the valuation and assessment of the properties of the said company for school purposes, is hereby ratified and confirmed and declared valid and obligatory.
