



CHAPTER 180

An Act to ratify by-law No. 54 of the municipality of the village of Masson and a resolution of the school commissioners of Notre-Dame-des-Neiges-de-Masson dated December 29th, 1929

[Assented to, the 20th of March, 1930]

WHEREAS the James MacLaren Company, Limited, Preamble.

has, by its petition, represented that on the 22nd day of June, 1928, a by-law bearing No. 54 was passed by the municipal council of the municipality of the village of Masson which granted unto said James MacLaren Company, Limited, its successors and assigns, a fixed valuation of two hundred thousand dollars for municipal purposes, for a period of twenty years, on the lands, waterpowers mills, factories, power-houses, buildings and erections, machinery, plant and improvements, railways, tramways, transmission lines and other properties of the said company in the said village of Masson, and other rights and privileges;

That these concessions were made to the said company in view of the establishment in said municipality of an industry which would be of great benefit to said municipality and give employment to a great many people and contribute largely to its development and progress;

That said by-law was submitted to the approval of the electors who are proprietors in the said municipality and was approved without a dissenting vote;

That it is expedient that the said by-law be ratified and approved by the Legislature in order to give it force and effect;

That the school commissioners of Notre-Dame-des-Neiges-de-Masson within whose territory the said properties are situate, at a meeting held on the 29th day of De-

ember, 1929, approved said by-law insofar as they were concerned, subject to the said valuation being increased for school purposes to two hundred and fifty thousand dollars from the 2nd to the 5th years, to three hundred thousand dollars from the 6th to the 10th years, to four hundred thousand dollars from the 11th to 15th years and five hundred thousand dollars from the 16th to the 20th years;

Whereas it is expedient that the said resolution be partly ratified and confirmed; and

Whereas it is expedient to grant in part the prayer of said petition;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of the Province of Quebec, enacts as follows:

By-law
ratified.

1. By-law No. 54 of the municipality of the village of Masson granting to the James MacLaren Company, Limited, its successors and assigns, a fixed municipal valuation of two hundred thousand dollars, for a period of twenty years, is hereby ratified and confirmed and declared valid and obligatory as regards the valuation therein contained.

2. The resolution of the school commission of Notre-Dame-des-Neiges-de-Masson, of date the 29th day of December, 1929, respecting the valuation and assessment of the properties of said company for school purposes, is hereby ratified and confirmed and declared valid and obligatory as regards the valuation therein contained but for the first ten years only.

3. This act shall come into force on the day of its sanction.
