



CHAPTER 49

An Act respecting the Montreal Protestant Central School Board

[Assented to, the 22nd of February, 1929]

HIS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. Section 4 of the act 15 George V, chapter 45, is replaced by the following: 15 Geo. V, c. 45, s. 4, replaced.

“4. 1. The Central Board shall consist of seven members professing the Protestant religion, and residing within the territory of the school municipalities mentioned in section 2 of this act. Central Board.

2. Commencing in 1929, and every four years thereafter, the members shall be appointed for the term of four years in the following manner: Appointment and term.

a. Four shall be appointed by a resolution of the Protestant Board of School Commissioners of the city of Montreal passed at a regular or special meeting on or before the fifteenth day of June; Four, by the Board, Montreal.

b. One shall be appointed by a resolution of the Protestant Board of School Commissioners of the city of Westmount passed at a regular or special meeting on or before the fifteenth day of June; One, by the Board, Westmount.

c. One shall be appointed by the Protestant boards of school commissioners or trustees of the school municipalities of Lachine, Coteau St. Pierre, Mount Royal and Verdun. Each such Protestant board, at a regular or special meeting held on or before the twentieth day of May, shall by resolution appoint a delegate to proceed with the election of such member of the Central Board. The delegates so appointed shall meet at the place named by the Director of Protestant Education in the Province, on or be- One, by boards of Lachine, Coteau St. Pierre, Mount Royal and Verdun.

fore the fifteenth day of June upon convocation by written notice of five days given by the said Director by registered letter, and shall then and there choose such member by the majority of the delegates present. The omission by any board to appoint its delegate shall not prevent the making of the appointment;

One, by the boards of Outremont, St. Laurent, Hampstead, Sault au Récollet and Pointe aux Trembles.

d. One shall be appointed by the Protestant boards of school commissioners or trustees of the school municipalities of Outremont, St. Laurent, Hampstead, Sault au Récollet and Pointe aux Trembles. Each such Protestant board, at a regular or special meeting held on or before the twentieth day of May, shall by resolution appoint a delegate to proceed with the election of such member of the Central Board. The delegates so appointed shall meet at the place named by the Director of Protestant Education in the Province, on or before the fifteenth day of June upon convocation by written notice of five days given by the said Director by registered letter, and shall then and there choose such member by the majority of the delegates present. The omission by any board to appoint its delegate shall not prevent the making of the appointment.

Vacancies.

3. If, on the thirtieth day of June, the Director of Protestant Education in the Province has not been notified of the appointment of all the members as above-mentioned, any vacancies shall be filled by the Lieutenant-Governor in Council.

Term from 1st of July.

4. The seven members appointed as hereinabove provided will hold office from the first day of July."

2. Section 6 of the act 15 George V, chapter 45, is replaced by the following:

Communication of appointment.

"6. Every appointment made in virtue of this act must be communicated in writing within seven days to the Director of Protestant Education in the Province by the authority bound to make such appointment."

Present members continued in office for certain period.

3. The present members of the Montreal Protestant Central School Board are continued in office and in the exercise of their functions until and including the thirtieth day of June, 1929, and any vacancy occurring in their number shall be filled in the manner provided in section 8 of the act 15 George V, chapter 45.

Coming into force.

4. This act shall come into force on the day of its sanction.
