



## CHAPTER 68

### An Act to amend the Forest Engineers' Act

[Assented to, the 4th of April, 1929]

**H**IS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

**1.** Section 4 of the Forest Engineers' Act (Revised R. S., c. 221, Statutes, 1925, chapter 221) is amended by adding in the fourth line of paragraph 2 thereof, after the word: "engineering", the following words: "fixing the conditions of clerkship and of practical work for the cases not provided for in the first paragraph of section 8;" s. 4, am.

**2.** Section 8 of the said act is replaced by the following: Id., s. 8, replaced.

**"8.** There shall be admitted to membership in the Association of Forest Engineers of the Province of Quebec any person who, when applying for membership, possesses the following qualifications, to wit: is at least twenty-one years of age, is a British subject, is the holder of a diploma of forest engineering from the Quebec School of Surveying and Forest Engineering or the Montreal Polytechnic School, or from any recognized University of the Province of Quebec, and has paid the fee fixed by the by-laws for the admission of members in the Association, provided such person has been registered with the secretary of the Association as a student for a period of twenty months. Admission to membership.

Any person who, being at least twenty-one years of age and a British subject, has complied with the by-laws of the said Association and has proved his competency to the satisfaction of the board of examiners as hereinafter constituted, may also be admitted to membership in the Association of Forest Engineers of the Province of Quebec." **3.** Section 9 of the said act is amended by replacing the word: "twice", in the first line of the last paragraph thereof, by the word: "once".

**4.** Section 12 of the said act, as amended by the act 18 George V, chapter 70, section 1, is again amended by adding, after the first paragraph thereof, the following paragraphs:

Practice of  
profession.

"No person shall practise or exercise, in the Province of Quebec, the profession of forest engineer within the meaning of section 3, unless he is a member of the Association of Forest Engineers of the Province of Quebec or becomes a member under the provisions of this act, in connection with any works required to comply with the laws, regulations and orders of the Lieutenant-Governor in Council in force.

Exercise of

No one acts contrary to the provisions of this act when, without assuming the title of Forest Engineer and without doing work required for purposes of inventory or forest management, he carries out or causes to be carried out forest fire protection work or the work of laying out logging areas or of organizing lumbering therein, or exploration work required for that purpose, or other exploitation works from and including the felling of the trees."

**5.** This act shall come into force on the day of its sanction.
